- The Authority continues to work with TPZP to start construction at other priority locations
- Provided direction to TPZP about potential hazardous materials in soils beneath various parcels (ongoing)
- Provided recommendations for SWPPP BMPs throughout CP-1 in preparation for the rainy season (ongoing)
- Provided Stop Work Notices for 3<sup>rd</sup> party gas pipeline relocation without clearance and failure to maintain water diversion in Dry Creek Canal
- Provided NCRs for insufficient BMPs at Fresno River Viaduct and for improper concrete washout procedures at Avenues 11, 12 and San Joaquin River Viaduct (SJRV)

  - Completed abutment 1 footing (complete)
  - Completed frame 8 deck concrete placement (complete)
  - o Completed construction on Fresno Colony Canal 24 and continue construction on Canal 1 (ongoing)
  - Continued large CIDH piles at bent 2 to 6 (ongoing)
  - o Continued forming, reinforcement and concrete placement for parapet and derailment protection walls on viaduct (ongoing)
  - Continued to install post tension strands and grouting of post tension ducts at frame 8 (ongoing)
- Muscat Avenue
  - Continue work on concrete finish surface (ongoing)
- Private Access Road (FAMBRO Parcel):
  - Began chipping out bulge on box culvert (ongoing)
- American Avenue
  - Completed construction of bents 2 and 3 column bent caps (complete)
- ROW and Demo/Abatement
  - Transferred four (4) parcels in 1A/1B; four (4) properties were transferred this period (ongoing)
  - One hundred forty-six (146) structures have been remediated, one hundred seventy-seven (177) have been demolished (ongoing)
- One (1) design submittal received a Rejection with Comments (RWC), one (1) design submittal received a Statement of No Objection with Comments (SNOC), and one (1) submittal received a Resubmit with Recommended Modifications (RWRM) response. Ten (10) design submittals remain in review.
