The California High-Speed Rail Authority (Authority) announces the availability of the **Final Supplemental Environmental Impact Report (Final Supplemental EIR)** for the **Fresno to Bakersfield Project Section (F-B)** of the **California High-Speed Rail Project**.

The Fresno to Bakersfield Section Draft Supplemental EIR/EIS (November 2017) was prepared as a joint document to meet all pertinent requirements of both CEQA and NEPA. However, following publication of the Draft Supplemental EIR/EIS, the Authority and FRA have agreed to prepare the Final Supplemental EIR separate from the Final Supplemental EIS.

The Final Supplemental EIR is being made available to public agencies that commented on the Draft Supplemental EIR/EIS pursuant to the California Environmental Quality Act (CEQA) prior to Authority decisions at the conclusion of this project level environmental review. The Authority is the project's lead agency under CEQA.

The Authority's Board of Directors will hold a one day board meeting, October 16, 2018, to consider whether to certify the Final Supplemental EIR under CEQA, which completes the CEQA process, and whether to approve the Fresno to Bakersfield Locally Generated Alternative, the May 2014 Project, or no project at all.

The Authority will collaborate with the FRA in the subsequent preparation of a Final Supplemental EIS and Supplemental Record of Decision (ROD) for the Project in compliance with NEPA. The Final Supplemental EIS and Supplemental ROD are expected to be published in late 2018.
