Notes:

The vendor disputes included in the \$17.4M total consists of: WSP \$5.1M, Caltrans \$3.6M, PCJPB and City of San Mateo \$3.4M, CRB \$1.5M, DFJV \$1.2M, HNTB \$745K, Regents of UCSD \$485K, and other vendors \$1.4M. In Sep-18, there were 267 paid invoices totaling \$60.1M and 111 in-process invoices totaling \$56.5M.

The Authority has not had an aged invoice in 13 months (Nov-17 report).

- (1) Administration/Support Costs of general operations of the California High-Speed Rail Authority.
- (2) Construction/Right-of-Way Real property acquisitions and civil construction of the First Construction Section.
- (3) Rail Delivery Partners Provide program management services in support of the California High-Speed Rail Authority.
- (4) Regional Consultants Engineering firms conduct environmental clearance and preliminary engineering design.
- (5) Resource Agencies Provide support during the environmental review process leading to a Record of Decision.
- (6) Third-Party Agreements These agreements are for the relocation, modification, reconstruction, and/or protection of utilities, irrigation facilities, roadways, and railways that are in physical conflict with the proposed High-Speed Rail System alignment.
