CONSTRUCTION FROM ORANGE AVE TO OREGON AVE IN KINGS AND TULARE COUNTIES

Issued: June 15, 2018

FRESNO, CALIF. – The California High-Speed Rail Authority (Authority), in cooperation with design-build contractor Dragados-Flatiron Joint Venture (DFJV), announces embankment construction from Orange Avenue in Kings County to Oregon Avenue in Tulare County. Work is scheduled to begin Monday, June 18 and continue through the end of the year.

Road closures will not be required, however, drivers should watch for heavy truck traffic. Water trucks will be used for dust mitigation.

This work is part of Construction Package 2-3 (CP 2-3), the 65-mile stretch of high-speed rail between East American Avenue in Fresno County and one-mile north of the Tulare-Kern County line.



Embankment construction from Orange Avenue in Kings County to Oregon Avenue in Tulare County will begin Monday, June 18 and continue through 2018.

Road closures will not be required, however, drivers should watch for heavy truck traffic. Water trucks will be used for dust mitigation.



Construction signage will be in place to alert traffic. Pedestrian access will not be restricted.

This schedule is subject to change. For up-to-date information please visit BuildHSR.com or the Caltrans Quickmap. Traffic laws will be fully enforced and commuters are expected to be aware of the surrounding activities, remain alert and watch for construction vehicles and personnel. The public is asked to drive carefully and be extra cautious while traveling through the construction areas.
