



CONSTRUCTION & ROAD CLOSURE ALERT

CLOSURE ON CORNELIA AVENUE AND MISSION STREET IN FRESNO

ISSUED: SEPTEMBER 26, 2017

FRESNO, CALIF. – The California High-Speed Rail Authority (Authority), in cooperation with design-build contractor, Tutor-Perini/Zachry/Parsons (TPZP), announces construction on Cornelia Avenue and Mission Street between Shaw Avenue and Golden State Boulevard starting September 27, 2017.

Construction crews will be relocating sewer and water lines as part of the realignment of Golden State Boulevard (GSB) to accommodate high-speed rail tracks.

This work is part of Construction Package 1 (CP 1), the first 32-mile stretch of high-speed rail between Avenue 19 in Madera County and East American Avenue in Fresno County.



Cornelia Avenue

- Cornelia Avenue will be closed to through traffic between Shaw Avenue and Golden State Boulevard.
- Cornelia Avenue will be accessible from Golden State Boulevard.

Mission Avenue

- Mission Street will be closed to through traffic at Shaw Avenue and State Street.

Both closures will be in place beginning September 27 until late October.



- **Eastbound traffic on Shaw Avenue will be detoured north on Golden State Boulevard and back on to Cornelia Avenue.**
- **Westbound traffic on Shaw Avenue will be detoured to Barcus Avenue, then north on State Street to Golden State Boulevard and back to Cornelia Avenue.**
- **Drivers are expected to follow road signage and may experience delays. Pedestrian access will not be restricted.**

Traffic laws will be fully enforced and commuters are expected to be aware of the surrounding activities, remain alert and watch for construction vehicles and personnel. The public is asked to drive carefully and be extra cautious while traveling through the construction areas.
