

## 10 DRAFT EIR/EIS DISTRIBUTION

The distribution of this *San Francisco to San Jose Project Section Draft Environmental Impact Report (EIR)/Environmental Impact Statement (EIS)* emphasizes the importance of providing the environmental documents in a number of different formats so the information is fully accessible to members of the public. The distribution strategy includes the use of electronic media to support cost-effective, broad availability to the public and interested parties. The Draft EIR/EIS is available on the California High-Speed Rail Authority's (Authority) website ([www.hsr.ca.gov](http://www.hsr.ca.gov)). Printed and/or electronic copies of the Draft EIR/EIS and electronic copies of associated technical reports will be available at the repositories in Section 10.1, Repository Locations, during hours the facilities are open. Printed and/or electronic copies of the Draft EIR/EIS and electronic copies of associated technical reports are also available for review during business hours at the Authority's Northern California Regional Office at 100 Paseo de San Antonio, Suite 300, San Jose, CA 95113 and the Authority's Headquarters at 770 L Street, Suite 620 MS-1, Sacramento, CA 95814. A copy of the Draft EIR/EIS may also be requested by calling (800) 435-8670.

All persons, agencies, and organizations listed in this chapter have been informed of the availability of the Draft EIR/EIS and locations to obtain or review copies, as well as the timing of the minimum 45-day review and comment period. Notice of availability of the Draft EIR/EIS was published in the *Federal Register*. Repositories listed in Section 10.1 and cooperating federal agencies were sent printed and electronic copies of the Draft EIR/EIS. Copies were also filed with the California State Clearinghouse. Each county through which the San Francisco to San Jose Project Section (Project Section, or project) would pass received an electronic copy of the Draft EIR/EIS, and a copy of the Notice of Availability (NOA) were displayed at each of the County Clerk offices, either in hardcopy or electronic format on their website. Other federal agencies, state agencies, and interested parties listed in the following subsections have received electronic copies of the Draft EIR/EIS. The Draft EIR/EIS Summary was translated into the primary languages of the project vicinity—Spanish, Chinese, Vietnamese, and Tagalog—and these versions of the Summary are available via the Authority's website, the repositories listed in Section 10.1, the Authority's Northern California Regional Office at 100 Paseo de San Antonio, Suite 300, San Jose, CA 95113, and the Authority's Headquarters at 770 L Street, Suite 620 MS-1, Sacramento, CA 95814. Federal, state, and county elected officials; mayors of cities with possible stations; potentially affected local agencies; local elected officials, agency representatives, owners and occupants of property contiguous to the parcel or parcels on which the project would be located and all others on the project mailing list not listed in this chapter have been mailed the NOA that includes information about how to access the Draft EIR/EIS; the timing of the minimum 45-day review and comment period; and community open houses and public hearing dates, times, and locations.
