Introduction and Letter of Assurance and Policy Statements

The California High-Speed Rail Authority (Authority) presents to the Federal Railroad Administration (FRA) the annual report on the Authority Title VI Program. This report reflects accomplishments, organizational, policy, implementation changes, and planned activities. The intent of this report is to demonstrate the Authority compliance with its nondiscrimination policy to involve the public, regardless of race, national origin, color, sex, minority or low-income status and language proficiency, in all of its programs and activities.

This report follows the best practices of 49 Code of Federal Regulations Part 21 and encompasses Title VI, Limited English Proficiency and Environmental Justice activities during October 1, 2014, to December 31, 2015, and planned activities for 2016, January 1, 2016 to December 31, 2016.

Jeff Morales, Chief Executive Officer (CEO), signed the Letter of *Assurance and Certification of Nondiscrimination in its Services and Activities* on March 18, 2015. The policy statements and the 2015 letter of Assurance are posted on the Authorityøs website: www.hsr.ca.gov/Title_VI_Program.aspx. Refer to Attachment A for the Letter of Assurance.

Organizational Structure and Key Personnel

The Authority's Board of Directors sets direction for the organization and governs through board policies and objectives. The Board of Directors consists of nine members: five members are appointed by the Governor, two members are appointed by the Senate Committee on Rules, and two members are appointed by the Speaker of the Assembly. Each Board member represents the entire State and serves a four-year term.

The CEO reports directly to the Board of Directors and seeks approval and guidance on a broad range of issues regarding the ongoing program including certifying environmental documents, entering into contracts, making project alignment decisions, and adopting business plans. Attachment C reflects the Authority's Executive Management Organizational Chart, effective December 2015.

Meetings of the Board of Directors are noticed and conducted in compliance with the Bagley-Keene Open Meeting Act. The Board of Directors meetings are generally held once a month. Special meetings may be held as needed to address Authority business; those meetings will be announced ten days in advance in compliance with the Bagley-Keene Open Meeting Act.

The Chair of the Board of Directors is Dan Richard and the Vice Chairs are Tom Richards and Thea Selby. There were changes to the Board during the reporting period: Senate President Pro Tempore Kevin de León appointed Lou Correa to the Board in March 2015 to replace Richard Frank; and Senate Speaker Toni G. Atkins appointed Daniel Curtin in May 2015 to replace Patrick W. Henning Sr. Two vacancies currently exist with the departures of Jim Hartnett and Katherine Perez-Estolano.

CEO Jeff Morales provides executive leadership over all Authority activities, including management and oversight of the Authority day-to-day operations. He reports directly to the Board of Directors and is responsible for determining the appropriate organizational structure for the Authority, selecting key management staff, facilitating discussion and agreement between the Board members, and establishing key management plans as well as executing the risk management, budgetary, compliance, and other organizational processes.

Deborah Harper was appointed as the Chief Administrative Officer and Title VI Coordinator on December 1, 2014. She is responsible for the development and administration of the Title VI Program, Limited English Proficiency and provides Environmental Justice guidance. The Title VI programs are supported by the External Affairs Division, Office of Environmental Services and the Rail Delivery Partner.

Lisa Marie Alley was appointed as the Chief of Communications on October 12, 2015 and oversees the External Affairs Division. She is responsible for the development and implementation of all internal and external communications activities, including media relations. She also facilitates a comprehensive stakeholder outreach campaign that promotes full and fair public participation in the High-Speed Rail Program decision-making process. The High-Speed Rail Program has multiple geographical project sections. Each project section has an Outreach Team responsible for implementing public participation plans in compliance with the project support and Title VI requirements.

The Authority has three Regional Directors. The Regional Directors are: Ben Tripousis, Northern California Regional Director; Diana Gomez, Central Valley Regional Director; and Michelle Boehm; Southern California Regional Director.

Under the direction of the Chief Executive Officer and in coordination with the Chief of Communications, each of the Regional Directors has key roles in the implementation of the High-Speed Rail Program and is responsible for ensuring their region moves forward on the planned schedule and budget. They develop and maintain relationships with local residents, policy makers, and Authority personnel while building strategies for communicating with local constituents to foster their continued involvement and support.

The Regional Directors are familiar with the cultural, linguistic, and social diversity for their respective area of responsibly. The public meetings are planned with the intent to reach and accommodate the diversity, culture and languages spoken of the regions.

Accomplishments

We acknowledge public involvement is fundamental and essential in achieving equitable program, services and activities. Public participation provides for the public involvement of all persons (including Native American Tribal Governments), minorities and low-income persons, affected public agencies, employees, the general public, transportation service providers, public transit users and other interested parties in communities affected by rail programs and projects. We also recognize public participation is a successful measure to notify the public of their civil rights under Title VI, Limited English Proficiency and Environmental Justice requirements for the Authority services, projects and activities.

The Authority seeks out and considers the viewpoints of all communities in the course of conducting public outreach and involvement activities. Our public participation strategy offers early and continuous opportunities for the public to be involved in the identification of social, economic, and environmental impacts of proposed rail decisions.

The factors that we use for effective public participation include:

- Time, location, and accessibility of meetings.
- Reaching people within their own communities and during existing meeting schedules.
- Provisions of Limited English Proficiency interpreters at meetings.
- Presentations focused to specific interests of groups.
- Placement of meeting announcements and flyers through different types of media.
- Identification of barriers to overcome public participation.
 - Coordination with individuals, institutions, or organizations and implementation of community-based public involvement strategies to reach out to members in the affected minority and/or low-income communities.
 - (2) Provide opportunities for public participation through means other than written communication, such as personal interviews or use of audio or video recording devices to capture oral comments.
 - (3) Use of locations, facilities, and meeting times that are convenient and accessible to low-income and minority communities.
 - (4) Use of different meeting sizes or formats, or varying the type and number of news media used to announce public participation opportunities, so that communications are tailored to the particular community or population.

We engage the public by:

- Encouraging public comments at the monthly Board of Directors meeting.
- Encouraging public comments at the bi-monthly Business Advisory Council meetings.
- Encouraging collaboration between diverse groups of community leaders. This collaboration enables various communities to help shape the Program.

- Participating in public involvement activities (meetings, hearings, advisory groups, workshops and task forces) to help the community understand the project, identify community interest and needs, eliminate perceptions, and define project goals.
- Developing clear, concise and understandable documents for members of the public, including EJ individuals, to provide comments on proposed projects.
- Implementing the Authority & Limited English Proficiency Plan to the fullest extent possible.
- Conducting public meetings that are accessible to all, as well as persons with disabilities; and include visual and tactile presentation tools and techniques.
- Using traditional and non-traditional media (website, local newspapers, radio and television stations, signs, etc.) to provide the public, including Environmental Justice groups with information about upcoming public participation events.
- Distributing information such as flyers or handbills through mass mailings, postings at community centers, retail stores, religious centers and social gathering events.
- Hosting a table or booth at community-based events.
- Making public information available in electronically accessible formats.
- Partnering with community-based organizations that serve underrepresented populations and minority and women business organizations.

We facilitated and participated in numerous public participation events in 2015. To determine the frequency and adequacy of contact with the public, including Environmental Justice populations, the Authority used the Public Participation Survey form at public meetings it sponsored. This survey form enabled us to collect data to identify residents and communities impacted by the high-speed rail project. Completion of the survey by the public was voluntary. We also used its Public Participation Visual Tally form as an indirect method for collecting data when at least 50 percent of the participants did not complete the Public Participation survey.

The Annual Community Outreach Tallies (Attachment D) summarizes the demographic data of the participants at the Authority sponsored public events, board meetings and small business workshops held during October 1, 2014 through December 31, 2015. It is estimated that more than 5,121 members of the public attended Authority sponsored outreach events. The Title VI Coordinator analyzed the information to determine if changes needed to occur to meet Title VI obligations. Overall we are making sufficient efforts, through various forums and meetings, to engage the public to attend and comment on the program. The information in the tallies submitted does suggest the public is reluctant to complete and submit the Public Participation Survey form. We are relying on visual assessments to determine the public participation levels by age, race, ethnicity, gender and disability. We will continue to disseminate the Public Participation Survey forms and will encourage participants to complete the forms.

Title VI of the Civil Rights Act of 1964 and related statutes state that no persons in the United States shall, on the grounds of race, color or national origin be excluded from participation in, be denied the benefits of, or be otherwise subjected to discrimination under any program or activity, receiving federal financial assistance. Pursuant to this mandate, the Authority takes affirmative steps to ensure that discrimination, as addressed by Title VI, does not occur in its organization.

The Title VI Program accomplishments were:

- Ensured monthly Board of Director meetings provided opportunities for public comment on each agenda item under consideration.
- Increased our public outreach to Limited English Proficiency individuals by translating community event flyers, fact sheets, and presentations in various languages including Spanish, Hmong, Chinese, Filipino, and Vietnamese
- We also continue to maintain hotlines in multiple languages such as Spanish and Hmong
- Continued to maintain the email account: TitleVICoordinator@hsr.ca.gov for the public to submit requests for information, comments or concerns.
- Requested and received annual letters of *Assurance and Certification of Nondiscrimination in its Services and Activities* from 22 consultants and contractors.
- Maintained the Small and Disadvantaged Business Enterprise (SB/DBE) Program, Policy and a
 30 percent overall goal, inclusive of DBE and Disabled Veteran Business Enterprise (DVBE) participation on Authority design-build contracts. The Authority's Small Business webpage at



- Pre-Bid Conference for Request for Qualifications (RFQ) HSR 15-01 for Project and Construction Management Services for Construction Package 4 in Wasco on June 24, 2015.
- Pre-Bid Conference for Request for Qualifications (RFQ) HSR 15-34 for Environmental and Preliminary Engineering Services in San Francisco on August 12, 2015.
- Pre-Bid Conference for Request for Qualifications (RFQ) HSR15-93 for the Vision Plan for High-Speed Rail stations in Sacramento on December 1, 2015.

- Industry Forum for Request for Qualifications (RFQ) HSR 14-32 for Design-Build contract Services for Construction Package 4 (CP 4) in Bakersfield on December 5, 2014. We hosted an Industry Forum for Prime Contractors and Small Businesses to network and gather information regarding Construction Package 4. This event provided an opportunity for small businesses that were interested in working on the Tulare/Kern County Line to just north of Bakersfield Project
- Industry Forum for Request for Qualifications (RFQ) HSR 14-66 for Rail Delivery Partner in Sacramento on January 23, 2015. We hosted an Industry Forum for Prime Contractors and Small Businesses interested in networking and gathering information regarding the Rail Delivery Partner Request for Qualifications

- Industry Forum for Request for Proposal (RFP) HSR 14-32 for Design-Build Contract Services for Construction Package 4 (CP 4) in Wasco, CA on June 10, 2015. We hosted an Industry Forum for businesses interested in working on the next 22-mile phase of construction in the Central Valley.
- Participated in five contract evaluation panels to ensure equitable involvement of Small, Disadvantaged Business and Disabled Veteran Business Enterprise companies.
- Partnered with various state agencies to host the Spring Procurement Fair on March 6th, 2015. The focus of this event was to match large private companies and government buyers with minority-owned, women-owned, disabled veteran owned and local small business vendors.
- Participated in 47 Small and Disadvantaged Business Enterprise outreach events, as sponsored by government entities and the business community, to disseminate information on the Small Business (SB) Program and contracting opportunities.
- In the second quarter of the Fiscal Year 2014-15, we executed nine new prime contracts that include commitments from 21 certified small businesses to work on high-speed rail.
- Held five Business Advisory Council (BAC) meetings. This 25-member Council represents statewide SB/DBEs and DVBEs and non-minority construction and professional; services business trade associations. The BAC serves as a forum to provide essential input and advisement to the Authority to enhance small business participation on the High-Speed Rail Program. In 2015, the Authority enacted five BAC recommendations to improve the SB/DBE Program. The recommendations were:
 - Include Contractor Bonding Assistance on the Small Business Development Services RFP.
 - Increase the overall project information and communications with the BAC members.
 - Provide a presentation on the Retention Release Process.

- Add language to the Design-Build Contract General Provisions to indicate that retention will be returned upon acceptance of work completed.
- As of June 2015, there are 240 certified small businesses statewide working on the Program. This is broken down regionally: Northern California, there were 83 certified small businesses; the Central Valley provided 54 certified small businesses; and the Southern Region produced 89 certified small businesses. There were 14 certified small business located outside California.
- From Redding to San Diego, small businesses across the state provided key professional and construction services, that resulted in more than \$17 million pumped into small businesses over the three-month period.
- Continuation of the Community Benefits Agreement (CBA) with 79 labor unions and the Design-Build contractors. The CBA Policy and Agreement require the Authority to engage with public partners, contractors and

Small Business Participation

As of June 2015, there are 240 certified small businesses statewide working on the Program.

- labor unions to ensure that the construction career and related jobs and opportunities created by the rail project are afforded to the community, including providing priority to those who are economically disadvantaged, thereby providing meaningful benefits and reinvestment to communities at large.
- Maintained a National Targeted Hiring Initiative (NTHI) Plan. The construction related targeted hiring requirements for construction contracts are: (1) A minimum of 30% of all hours of Project Work shall be performed by National Targeted Workers; and (2) A minimum of 10% of the 30% National Targeted Workers hours shall be performed by Disadvantaged Workers.
- The Construction Package 1, Contractor achieved 72 percent in NTHI hours worked. This represents 33,029.5 hours out of 45,775.5 hours worked by all craft trades on the CP-1. This further represents that the 30 percent worker hours' goal was exceeded.
- The Labor Compliance Unit implemented usage of its Labor Compliance Review Manual to conduct compliance reviews. The manual describes our standard operating procedures for conducting Davis Bacon Act and California State Labor law compliance reviews of the contractors and subcontractors.
- Labor compliance reviews were completed with the following accomplishments:
 - o 25 subcontractors were reviewed for document compliance.
 - o 169 employees were listed on the Certified Payroll Records and reviewed for classification and prevailing wage requirements.

The Right of Way team assisted in several successful relocations and negotiations.

- Stars Dance Studio was located in the future path of the High-Speed rail and therefore had to be relocated. Although the relocation process took longer than anticipated, the owner stated that the studio's doors remained open. The new studio is twice as large as the old one, boasting more classroom, lobby and office space.
- A contractor that provides Right-of-Way (ROW) services for the Authority, received numerous letters commending its ROW agents. Below are excerpts from some of the letters:
 - A Fresno developer and local business owner wrote: õAfter working with the CFS staff, I
 had a much more favorable impression of the project. I was confident that I would be treated
 professionally and fairly and I was.ö
 - One attorney representing seven property owners stated that the CFS team was õstraightforward, responsive and courteousí and undertook their duties in a professional manner.ö
 - A Hispanic property owner stated that the ROW agent took time to go over the paperwork to make sure that the owner fully understood before signing.
 - A business owner with very specific needs commended the ROW agent for showing them
 many properties in order to find a suitable one to relocate their family business. They are
 confident that the new location will be just as good as their current location.
 - An Eminent Domain attorney commended CFS for their õtimeliness and thorough explanation and patience (which) were invaluable in the processí after we reached an agreement you diligently facilitated documentation of the deal, including coordination various revisions between myself and HSR¢s counsel.ö
 - One farm owner wrote: õThank you for all your help and assistance whether it meant travelling down to our farm in Hanford or making the time to see us in your Fresno office. Because of the specialness of this project, you have definitely made the extra effort to welcome all our questions and address our concerns and for that we are very grateful!ö
 - An attorney representing four farm owners wrote: õI am writing to express collective appreciation for your professionalism, responsiveness, knowledge and ability to explain the acquisition process without any pressure on the clients.ö
- Monitored approximately 481 negotiations made by the Right of Way area for properties. The negotiatorsølogs were reviewed for compliance and no noted disparities exist. The table below summarizes the demographic data of parcels negotiated in each county.

- The Authority hosted three international delegations:
 - Korea Railway Research Institute. They discussed planning, status, construction of High-SpeedRail.
 - German Bundestag (Parliament) Delegation. CEO Jeff Morales met with seven parliamentarians representing all four German parties. They discussed the High-Speed Rail Program, the progress to date, financing models and challenge, and Public-Private Partnerships.
 - Japanese Delegation in San Jose on January 22, 2015. Northern Regional Director Ben Tripousis met with delegation from Japan.
- Hosted three Careers in Construction Workshops in Madera, Sanger, and Orange Cove between October 17, 2014 and November 19, 2014. Prospective workers attended these workshops to learn about jobs, training opportunities for work on High-Speed Rail and other construction job activities.
- Hosted the High-Speed Rail Official Groundbreaking on January 6, 2015. The ceremony broadcasted live, using sign language and closed captioning. Remarks from owners of a family-owned steel manufacturer already benefitting from high-speed rail construction were highlighted. Student leaders from Fresno State and University of California, Merced also explained how high-speed rail is creating new local opportunities.
- We executed 42 contracts during the period of October 1, 2014 and March 31, 2015. The types of contracts executed were Legal Agreements (6); Third Party (Utility, Federal and Local Governments, Railway) (18); Interagency Agreements (6); and Consultant Contracts (13). Title VI requirements have been included in all consultant contracts as referenced in the General Terms and Conditions (GTC 610), Con-

tractor Certification Clauses (CCC 307) and/or by referenced exhibit.

Statewide, we participated in community events hosted by other organizations to provide information related to the progress made on the High-Speed Rail Program, small business opportunities and job readiness.

- Friends of Light Rail & Transit in Sacramento on October 2, 2014. CEO Jeff Morales was the keynote speaker at the Friends of Light Rail & Transit annual event. This non-profit organization was established by transportation advocates, to promote public transit in the Sacramento region.
- Envisioning California Conference on October 3, 2014. We participated as a panel member at the
 Envisioning California Conference. Discussion included the benefits of the High-Speed Rail Program and business opportunities.

- UC Berkeley Engineering students on October 7, 2014. We spoke to UC Berkeley engineering class taught by Professor William Ibbs. Professor Ibbs testified during a hearing at the capitol about the High-Speed Rail Program not being able to meet its requirements. Professor Ibbs requested that CEO Jeff Morales come to the class to update students on the program and clear up misconceptions about California high-speed rail plans.
- Presented to Sacramento County Bar Association Luncheon on October 14, 2014. Assistant Chief Counsel James Andrew presented before the Sacramento County Bar Association. The presentation was an overview and update on progress of high-speed rail and discussed legal challenges.
- Construction Management Association of America (CMAA) National Conference & Trade Show on October 20, 2014. We participated in a panel focused on challenges of delivering a High-Speed Rail Program at the CMAA conference in San Francisco.
- California Law & Economics Symposium on October 24, 2014. General Counsel Tom Fellenz spoke at the California Law & Economics Symposium. He addressed benefits of high-speed rail, legal challenges, regulations and their impacts on the high-speed program.
- Transbay Joint Powers Authority on November 7, 2014. The Authority Board of Directors Chair
 Dan Richard spoke at a Transbay Transit Center Project event that celebrated the occasion of raising the first piece of above-ground steel for the project. Chair Richards discussed the partnership
 between the Transbay Joint Powers Authority to bring high-speed rail to downtown San Francisco.
- Focus on the Future Conference in Santa Clara on November 17, 2014. CEO Jeff Morales moderated the panel at the conference. Mr. Morales discussed statewide rail modernization, high-speed rail, inner-city rail and cap and trade.
- U.S. HSR, High Speed Rail Conference on December 2-4, 2014. CEO Jeff Morales presented the keynote address. Southern California Regional Director Michelle Boehm gave a presentation on the California Statewide Rail Modernization. Board member Thea Selby was on a panel entitled õA New Vision for Transportation in Americanö.
- Public Policy Institute of California in Sacramento on December 3, 2014. CEO Jeff Morales participated in a panel at the PPIC ó Public Policy Institute of California. The panel focused on areas in which public policy is driving California to the leading edgeô from climate change to high-speed rail to stem cell research.
- LegiSchool Project Town Hall on December 5, 2014. CEO Jeff Morales participated on a panel as part of a High-Speed Rail Town Hall meeting hosted by the LegiSchool Project and the Maddy Institute at Fresno State University. The meeting provided an educational forum in which California

 shigh school students, policy experts and state leaders can come together to discuss important policy topics. A panel discussion debating the pros and cons of the High-Speed Rail Program, followed by a reflection session between the moderator and high-school students that have been invited to attend. Approximately 140 students from local schools attended.
- International California Environmental Quality Act (CEQA) Conference in San Francisco on December 5, 2014. Assistant Chief Counsel James Andrew, Director of Environmental Services Mark McLoughlin and Northern California Regional Director Ben Tripousis were on a panel with

Street and Golden State Avenue. The community was able to ask questions and provide comments about the alignment that is being studied.

Limited English Proficiency Program

Throughout planning and construction activities, we have and will continue to engage Limited English Proficiency individuals in a variety of ways through translation of written materials and having interpreters on hand as needed.

Limited English Proficiency access is provided to individuals who represent more than five percent of the Limited English Proficiency population in California or the county in which we are providing an activity or service. The table below identifies the counties impacted by the High-Speed Rail Program and the languages spoken at home during 2009-2013. This information is acquired from the American Community Survey 5-Year Estimates - U. S. Census Bureau Language Spoken At Home demographics.

The Limited English Proficiency Accomplishments were:

- Hosted three Careers in Construction Workshops in Madera, Sanger, and Orange Cove between October 17, 2014 and November 19, 2014. We translated written material into Spanish and offered Spanish interpreters at both the Sanger and Orange Cove workshops.
- Hosted High-Speed Rail Official Groundbreaking on January 6, 2015. Utilized sign language and closed caption services.
- Hosted four open house meetings from April 30, 2015 through September 10, 2015. These open houses were held to discuss concerns regarding Construction Package 1. Language assistance was offered in Spanish and Hmong. We also offered meeting facilities assistance for persons with disabilities.

- Hosted nine community open house meetings during May 16 through June 6, 2015 to discuss the Palmdale to Burbank Project Section. Language assistance was offered in multiple languages including Spanish, Thai, Russian, Armenian, Korean, and Tagalog.
 - There were seven requests for Spanish language assistance and one each for Armenian, Tagalog, Russian, Thai and Korean. All meeting materials including the event flyer, a project section factsheet and the statewide fact sheet were provided in Spanish, as was Title VI information.
- Conducted an all-Spanish presentation with an emphasis on the San Fernando Valley and Pacoima communities before the Pacoima Beautiful, an environmental group.
- Conducted simultaneous presentations in English and Spanish at the Communities against Displacement, which addressed questions and comments from Sylmar, Pacoima, and San Fernando residents. Handout materials were also made available in English and Spanish.
- In January 2015, we sent out more than 6,000 Permit to Enter (PTE) Letters in the Central Valley and throughout Southern California. The PTE letters included information in the various languages identified for the areas receiving the notice, including: Spanish, Armenian, Russian, Thai, and Korean.
- There were nine requests for Spanish language translation headsets for the main presentation at the Bakersfield to Palmdale Project Section Community Meeting in Edison on September 30, 2015. All meeting materials including a project section factsheet and the statewide fact sheet were provided in Spanish, as was Title VI information.
- Conducted seven open house meetings throughout Southern California between December 2 and 13, 2014. Interpretation services were offered. All handout materials were offered in English and Spanish, and a request form for other languages was made available to the public.
- Eight Community Working Groups (CWG) were formed and meetings were conducted in communities along the Palmdale to Burbank Project Section throughout February and March 2015. These meetings were accessible to the public, but not publicly advertised as the format is designed for small group (approximately 30 members) discussions for constructive collaboration to support the route planning process. The CWGs are comprised of community representatives from various constituencies in proximity to the Palmdale to Burbank corridor and local interest groups involved in transportation, environmental sustainability, and social issues in the region. All meeting materials were made available in English and Spanish.
- The presentation for the April 2015 Palmdale to Burbank Community Working Group Meeting is translated in Spanish and posted on the Authority website: Community Working Group Power-Point Presentation.
- A live webcast of the presentation was provided in Spanish at the Palmdale to Burbank Community Open House Meeting, in the City of San Fernando on May 28, 2015.
- A presentation in Spanish was given at the Palmdale to Burbank Community Open House Meetings in San Fernando on May 28, 2015 and in Palmdale on June 2, 2015.
- Right-of-Way documents are available in four languages: Simplified Chinese, Hindi, Spanish and Traditional Chinese.

- ROW completed 481 negotiations during this fiscal year. Fifty-one negotiations involved providing language assistance to Limited English Proficiency property owners or tenants.
- Documents encompassing Environmental Considerations and Open House Meeting Presentations were translated into Spanish and are posted on the Authority website for the Palmdale to Burbank Project Section Community Open House Meetings in May and June 2015.
- Hosted four open house meetings from September 8, 2015 to October 7, 2015. These open houses were held to discuss program updates, respond to questions, and gather public feedback for the San Francisco to San Jose and San Jose to Merced Project Sections. Language assistance was offered in Spanish, Vietnamese, Chinese, and Tagalog.
- Hosted five community open house meetings during October 15, 2015 through October 28, 2015 to discuss the Los Angeles to Anaheim Project Section. Language assistance was offered in Spanish and Korean. Flyers were translated in Spanish.
- Hosted three open house meetings from November 10, 2015 through November 19, 2015. These open houses were held to discuss the alternatives being evaluated for the Burbank to Los Angeles Project Section. Language assistance was offered in multiple languages including Spanish, Chinese, Armenian, Japanese, Korean, Russian, Tagalog, Vietnamese, and Arabic.
- Hosted four open house meetings from November 19, 2015 through December 3, 2015. These
 open houses were held to discuss concerns and to respond to questions regarding Construction
 Package 2-3. Language assistance was offered in Spanish and Hmong. We also offered meeting
 facilities assistance for persons with disabilities.

Environmental Justice Program

Environmental Justice is the fair treatment of people of all races, cultures, and income with respect to the development, adoption, implementation and enforcement of environmental laws and policies. Implementation of environmental justice principles in how we plan, design, and deliver the High-Speed Rail Program means that we recognize the potential social and environmental impacts that project activities may have on certain segments of the public. We recognize how important provisions of existing environmen-

tal, civil rights, civil, and criminal laws may be used to help reduce environmental impact in all communities and environmental justice on the human element.

The Authority has included environmental justice considerations in its planning for the statewide high-speed train system since 2000, when it commenced a programmatic environmental review process.

The Environmental Justice Accomplishments were:

- Conducted a presentation before Pacoima Beautiful, an environmental justice organization that
 provided a thorough overview of the Project Section with an emphasis on the San Fernando Valley and Pacoima communities.
- Quarterly Native American Advisory Committee members, on November 12, 2014, February 18, 2015, May 13, 2015 and August 12, 2015. We presented an overview and update of the High-Speed Rail Program to representatives from tribes statewide.
- Governor

 agency/department tribal liaisons
 ø quarterly meetings on November 20, 2014. We participated in this meeting that involved updates and information from the Office of the Governor
 øs Tribal Liaison regarding agency tribal consultation policies, legislative update and training opportunities.
- The Authority and FRA held a formal consultation meeting with the non-Federal tribe, the Chowchilla Tribe of Yokuts, a Section 106 Consulting Party to the Merced-Fresno and Central Valley Wye Project Sections, on March 26, 2015. The purpose of the meeting was to provide updates and the status regarding the Central Valley high-speed rail project sections, as well as to solicit input/feedback from the tribes regarding concerns for important tribal cultural resources.
- Los Angeles Cleantech Incubator on December 5, 2014. Southern California Regional Director Michelle Boehm spoke at the monthly meeting. Ms. Boe
- hm gave an overview of the Program and discussed sustainability, environmental and green aspects of High-Speed Rail along with business opportunities.
- Sustainatopia 2015 in Century City on May 27-30, 2015. We presented during Friday, May 29th
 øs Plenary Session: the Future of Cities. Southern California Regional Director Michelle Boehm spoke about net zero emissions, GHG reduction and sustainability policy at Sustainatopia in Los Angeles.
- We met with various local leaders on March 12, 2015. Representatives such as Beatris Espericueta Sanders, Executive Director, Kern County Farm Bureau; Erica Andrews, Superintendent, and Matt Carter, Director of Maintenance, Operations and Transportation, Edison Elementary School District; and Lorelei Oviatt, Planning Director, and Craig Murphy, Advance Planning/Community Development Division Chief, Kern County Planning and Community Development attended our presentation regarding the Bakersfield to Palmdale Project Section update and overview of possible alignments in the Edison and Kern areas. We also discussed potential impacts to agricultural resources.
- Annual California State Transportation Agency (CalSTA) tribal consultation meeting on June 18,
 2015, in Lincoln. All California state tribal leaders and representatives were invited and had opportunity to discuss statewide transportation issues.

- Hosted a Tribal Information Meeting with: San Manuel Band of Mission Indians, Gabrieleno Band of Mission Indians, Fernandeno Tataviam Band of Mission Indians; Tongva Ancestral Territorial Tribal Nation and Gabrielino/Tongva Nation on September 25, 2015. The purpose of the meeting was to provide information to the tribes about the High-Speed Rail Program, the status and plan for the Palmdale to Burbank and Los Angeles to Burbank Project Sections, the status and plan for the cultural resources investigation; and how they can become involved in the process.
- The Authority Tribal Liaison was a speaker at the California Native American Heritage public session on October 17, 2015. She provided an overview of the High-Speed Rail Program and the cultural resources compliance process as it relates to the delivery of the high-speed rail project.
- Hosted a Bakersfield to Palmdale Tribal Outreach Meeting in Bakersfield, on November 5, 2015 to gather comment and update the community on the current status. Representatives from the twelve following tribes will be invited: San Manuel Band of Mission Indians, Tejon Indian Tribe, Tule River Indian Tribe of California, Santa Rosa Tachi Tribe, Kern Valley Indian Council, Kitanemuk & Yowlumne Tejon Indians, San Fernando Band of Mission Indians, Kawaiisu Tribe of Tejon Reservation, Fernandeno Tataviam Band of Mission Indians, Soboba Band of Luiseno Indians, Santa Ynez Elders Council, Table Mountain Rancheria Tribe.
- Approved agreement with Central Valley Air Pollution Control District to offset emissions during construction by replacing aging farm and other equipment, including replacing school bus engines and irrigation pumps.
 - o As of November 2015, the Air District has offset 25.76 tons of pollution through the replacement of 35 engines on farm equipment and trucks in the Central Valley.
 - o Deployed Tier IV construction equipment, including cranes, crawlers and excavator, which meets the nation most stringent environmental standards, to help protect air quality and reduce greenhouse gas pollution.
 - o A Fresno-based small business is using a biodegradable product called EarthGuard for dust control, soil erosion and storm water quality management within Construction Package 1. This product is applied on vacant land after demolition activities have occurred to hold soils in place. It also prevents dirt and harmful chemicals that may be in the soil from fouling the Valleyøs water and air.
- We continue our work with the Colony of Fairmead. A land use analysis was conducted to better understand how and where development was occurring and catalog plans for transportation and other improvements in the area that would affect Fairmead independent of the Authorityøs program. On behalf of Fairmead, we reached out to the Governorøs Office of Planning and Research (OPR) because they are actively working on rural community outreach. Our intent is to connect Fairmead with technical assistance and contacts for programs that could help them pursue grants and other financial assistance for project.

Title VI, Limited English Proficiency, and Environmental Justice Training

The Title VI Coordinator provides Authority personnel training on Title VI, Limited English Proficiency and EJ Guidance. The training component includes the salient points of the Title VI Program, Limited English Proficiency Program and EJ Guidance and how the three components provide meaningful access to the public on the Authority programs and services.

- The Authority conducted two training sessions on Title VI, Limited English Proficiency and EJ trainings for its new staff on January 15, 2015.
- Eleven Authority staff attended the training.

Although some training was provided, we did not meet our goal to provide training for all members of the High-Speed Rail team.

Title VI Complaints

Complaint: On April 15, 2015, at the Authority Business Advisory Council (Council) meeting, during the public comment component of the Council agenda, a member of the public alleged that the Authority did not have a plan to comply with Executive Order 12898, õFederal Actions to Address Environmental Justice in Minority Populations and Low-Income Populationsö The Council members augmented the public comment and requested information from the Authority to provide evidence that the Authority does in fact have an Environmental Justice guide.

Finding: The allegation had no merit. On April 24, 2015, the Authority formally responded to the Council members and the public with five (5) documents that demonstrate the strong efforts the Authority has undertaken and continues to undertake in regards to Environmental Justice for the populations the project will serve. The documents included the Environmental Justice Guidance which lays out the Authority policy; Board of Directors Resolution Number HSRA 12-22 which approved the Authority Environmental Justice Policy and Guidance; the briefing memo for the preceding Board of Directors resolution; slides summarizing the Policy and Guidance, and the directive authorizing the adoption of the Policy signed by CEO, Jeff Morales. On the request of the Council, the Authority provided the weblink to the Environmental Impact Report (EIR) for Fresno to Bakersfield. The final EIR/Environmental Impact Statement for Fresno to Bakersfield was approved on May 7, 2014, at public Board of Directors meeting held in Fresno, California.

Disposition: Closed.

Planned Activities in Calendar Year 2016

The Authority takes serious its compliance with Title VI, Limited English Proficiency and Environmental Justice to ensure that the public we serve are provided every opportunity to provide input, participate in

and have the benefits of ridership on the high-speed rail train. The Authority recognizes calendar 2016 will result in greater public awareness of the High-Speed Rail Program as construction in the Central Valley continues and we advance planning and environmental review in Northern and Southern California. As the High-Speed Rail Program expands and impacts more communities, we will continue to enforce and implement the Title VI, Limited English Proficiency, and Environment Justice Programs.

In 2016, the Authority's planned activities, in compliance with Title VI, Limited English Proficiency and Environmental Justice are:

Business Advisory Council Meetings

• Host six Business Advisory Council (BAC) meetings scheduled February 17, 2016, April 20, 2016, June 16, 2016, August 18, 2016, October 20, 2016 and December 8, 2016.

Board of Director Meetings

Host 12 Board of Directors meetings throughout 2016. These meetings are scheduled for January 12, 2016, February 9, 2016, March 8, 2016, April 12, 2016, May 10, 2016, June 14, 2016, July 12, 2016, August 9, 2016, September 13, 2016, October 11, 2016, November 8, 2016, and December 13, 2016.

Open Houses, Community/Technical Working Groups

We host various types of meetings to receive public input. All meetings are open to the community. However our Community/Technical Working Groups (CWG) are smaller groups that are comprised of community representatives from various constituencies. The CWG is an informal, voluntary group of community members representing a broad range of local interests and is organized to deepen community input into the high-speed rail planning process

- We will continue to host open houses that enable the public the opportunity to learn more about the progress of the Project Sections that affect their communities.
 - We will host community open houses to enable the community to learn more about the proposed alignment alternatives under consideration and next steps for the Central Valley Wye.
 - We will host CP 1, CP 2-3 and CP 4 open houses to keep the communities informed of impacts construction will have in the region.
 - We will host two open houses in July, 2016 in the Southern California Region. The Los Angeles to Anaheim and Palmdale to Burbank Project Sections will be discussed and the public will be able to offer feedback.
 - We will host two open houses in September 2016 in the Southern California Region. The Burbank to Los Angeles.
 - We will have an open house to discuss the progress of the Palmdale to Burbank Project Section November 2016.
- We will continue to partner with various agencies to host technical working group meetings.
 - Partner with Caltrain to host technical group meetings to garner input for the San Francisco to San Jose Project Section.

- o Partner with Caltrain to host policy group meetings to gather input for the San Francisco to San Jose Project Section.
- Develop Community Working Group to garner input for the San Francisco to San Jose Project Section.
- Develop Technical Working Group to garner input for the San Jose to Merced Project Section
- Develop Technical Working Group to garner input for the San Jose to Merced Project Section.
- We will continue to host community working groups throughout the state to update the public on the progress made and request feedback for each project section. Below is a list of community working group meetings scheduled for calendar year 2016.

 - We will hold two community working groups for the Burbank to Los Angeles Project Section and the Los Angeles Project Section August 2016.
 - We will hold two community working groups for the Burbank to Los Angeles and Palmdale to Burbank Project Sections September 2016.
 - We will hold two community working groups for the Palmdale to Burbank and Bakersfield to Palmdale Project Sections in October 2016.

Small Business/Job Workshops

- Conduct Certification Workshops throughout 2016. It is anticipated that they will facilitate one session per month, per region for a total of 36 certification workshops.
 - O Post certification workshops are in development and will likely kick off in the Spring ó they too will be one per month, per region for a total of 24. Targeted topics such as õhow to do business with the state,ö bonding, insurance, and meeting prime contractors will be delivered. These workshops will also be statewide.
 - As with 2015, the Small Business program will continue to participate in conferences and speaking events hosted by community groups, minority associations and state partners. The Small Business program will continue to participate in High-Speed Rail hosted community

meetings, pre-bids, and meet the prime events to share the Small Business program efforts and goals.

Pre-bid Conferences and Industry Forums

- We will host pre-bid conferences and industry forums to enable businesses interested in working with High-Speed Rail the ability to obtain information and network.
 - Host pre-bid conference for Request for Qualifications for As-Needed Environmental Services for Merced to Fresno Project Section RFQ No. HSR 15-107 and Fresno to Bakersfield Project Section RFQ on January 21, 2016.

<u>Limited English Proficiency</u>

- Right of Way is working to provide "Relocation Assistance Program" information in additional languages including Spanish, Russian, Hmong.
- We will include õLanguage and Other Needsö verbiage on all Board of Director agendas.
- We are in the process of making the Authority® public website language accessible.
- Title VI Project Management Team will continue to monitor the submission of Limited English Proficiency Reporting forms to ensure language assistance services are documented.

Right of Way

- Right of Way is committed to treating all members of the community fairly and addressing any concerns that arise during negotiation or relocation.
- We will continue to guide residents through the Right of Way process in an efficient and dignified manner. Responding effectively and respectfully to questions and timelines.
- All members of the Right of Way team, including subcontractors, will participate in Title VI, Limited English Proficiency, and Environmental Justice training.

Environmental Justice

During 2016, we will advance the environmental phase for 10 areas throughout the state. It is our goal to enhance our environmental justice program to ensure compliance. We will continue community and stakeholder engagement throughout the planning and environmental review process.

- We will collaborate with members of the Environmental area to review, edit, and update our 2012 Environmental Justice Guidance Plan.
- We will create and offer Environmental Justice training to all members of the High-Speed Rail Program including Authority and Consultant staff.
- We will provide guidance to the Environmental Division as they compose an updated Environmental Justice Program Management Plan
- Environmental Planning Division will host Tribal informational meetings with Federally recognized, and non-Federally recognized Tribes, at key milestones in the process to provide regular project updates. The key milestones in the project planning process in which Tribal consultations

will occur include: (1) during scoping and process of identifying the range of alternatives; (2) during the historic property identification effort; (3) during the assessment of effects to historic properties; (4) during the development of mitigation for the resolution of adverse effects; and (5) during the implementation of treatment plans to resolve adverse effects.

- Cultural Resource Specialist will continue to provide informational updates for all tribes via
 meetings and update letters. There will be outreach to tribes on a system-wide basis to foster
 awareness, encourage participation and lay the groundwork for more meaningful consultations on
 specific rail sections.
- Cultural Resource Specialist will continue ongoing consultations with representatives from the
 various tribes to review high-speed rail project maps and identify culturally sensitive areas to be
 considered during the environmental review.
- The Authority is committed to building the High-Speed Rail System in a manner that is environmentally responsible and sustainable for all of our communities. The use of clean and green construction practices will continue to be utilized as activities increase. The Authority is committed to recycling 100 percent of all usable concrete and steel resulting from the demolition of buildings and structures along the alignment.

Training

- We will collaborate with each of the functional areas throughout the High-Speed Rail Program to provide training to all team members.
 - This training will consist of department-specific training along with a general overview of Title VI Program, Limited English Proficiency Program and Environmental Justice Guidance and how the three components provide meaningful access to the public on the Authority
 øs programs and services.
- Training will be offered to all members of the team and will be tracked to confirm that each team member has the opportunity to attend a training session.

Board of Directors

Current Roster as of September 2015

The Authority is composed of a nine-member Board of Directors that oversees planning, construction and operation of the nation first high-speed rail system. Five members are appointed by the Governor, the California Senate Rules Committee appoints two members, and the California Speaker of the Assembly appoints two members. As of September 30, 2015, the members of the Board are:

- 1. Dan Richard, Chair appointed by the Governor. Mr. Richard has been a principal of Dan Richard Advisors since 2010. Mr. Richard was managing partner and co-founder of Heritage Oak Capital Partners, an infrastructure finance firm, from 2007 to 2009 and was Senior Vice-President of Public Policy and Governmental Relations at Pacific Gas and Electric Company from 1997 to 2006. He was an elected member of the San Francisco Bay Area Rapid Transit District from 1992 to 2004, where he served twice as President of the Board.
- 2. Thomas Richards, Vice-Chair appointed by the Governor. Mr. Richards is Chair and CEO of The Penstar Group, a Fresno-based real estate investment, development and construction company. Mr. Richards' projects have extended from Santa Barbara to the Central Valley, from Sacramento to Bakersfield and in the Inland Empire from Corona to Victorville. Mr. Richards works with local government leaders to address homelessness issues in both the City and County of Fresno.
- 3. Thea Selby, Vice-Chair appointed by the Speaker of the Assembly. Ms. Selby is currently a principal at Next Steps Marketing in the San Francisco Bay area. She was a Content Chair of Exceptional Women in Publishings 2014 Womens Leadership Conferences and is a co-founder of the Lower Haight Merchant + Neighbor Association. She has been active in Bay Area political and advocacy for many years, with a special emphasis on social and community issues.
- 4. Lou Correa, Board Member appointed by the Senate President Pro Tem. Mr. Correa is a former member of the California State Senate representing the 34th District from 2006 to 2014. In 2012, Correa helped ensure that funding for projects in California & obookends was included in the final high-speed rail deal. He also fought to make sure the high-speed rail projects weren exempt from the Disabled Veterans Business Enterprise Program, helping disabled veterans compete for a portion of the contracting dollars that are competitively awarded through the state bidding process. Correa has served on the Board of the Orange County

- Community Development Council, the county anti-poverty council, the California Small Business Board, and the Orange County Boy Scouts.
- 5. Daniel Curtin, Board Member appointed by Speaker of the Assembly. Mr. Curtin has served as Director of the California Conference of Carpenters since 2001 and previously held the same position from 1992 to 1999. From 1999 to 2001, he served as Chief Deputy Director for the Department of Industrial Relations. Prior to that Mr. Curtin was a legislative advocate for the California Conference of Carpenters. He has been a champion of more than 100,000 working and retired union members in the carpenter industry. His experience in the California Labor movement began in 1973 when he started as a Union organizer and worked for the California Labor Federation.
- 6. Michael E. Rossi, Board Member appointed by the Governor. Mr. Rossi is the Senior Advisor for Jobs and Business Development in the Office of the Governor. In this role, Mr. Rossi will be the point of contact between California business and workforce leaders and the Office of the Governor. Mr. Rossi currently serves on the Advisory Board of Shorenstein Properties LLC, the Court Appointed Special Advocates of Monterey County, Special Olympics Committee of Northern California and Claremont Graduate University. Mr. Rossi is a former Director of North Hawaii Community Hospital, BAWAG Bank (Austria), Pulte Homes, American Bankers Association, Monterey Institute of International Studies, American Graduate School of International Management, University of California at Berkeley Art Museum, Del Webb Corporation, BlueLinx Corporation, San Francisco Opera, National Urban League, Union Pacific Resources, Lifesavers, American Diabetes Association of California and United Way of Northern California.
- 7. Lynn Schenk, Board Member appointed by the Governor. In 1992, Ms. Schenk became the first woman elected to the United States House of Representatives to represent the San Diego area. Ms. Schenk served as Chief of Staff to California Governor Gray Davis from 1999 to 2003. As Chief of Staff to the Governor, she oversaw the day to day operations of state government through the 12 Cabinet agencies and more than 75 departments and offices. She managed the Governor's office staff of about 200 and had the homeland security office, the National Guard, and the Office of Emergency Services reporting directly to her. She was the Governor's chief executive and top policy advisor.
