REVISED DRAFT ENVIRONMENTAL IMPACT REPORT / SUPPLEMENTAL DRAFT FNVIRONMENTAL IMPACT STATEMENT

FOCUSED CONTENT ON TWO NEW CANDIDATE SPECIES AND MITIGATION FOR LIGHTING IMPACTS TO SPECIES

The California High-Speed Rail Authority (Authority) is issuing a limited revision of its previously published Draft Environmental Impact Report/Environmental Impact Statement (Draft EIR/EIS), pursuant to the California Environmental Quality Act (CEQA) and the National Environmental Policy Act (NEPA). The environmental review, consultation, and other actions required by applicable federal environmental laws for this project are being or have been carried out by the State of California pursuant to 23 U.S.C. 327 and a Memorandum of Understanding dated July 23, 2019 and executed by the Federal Railroad Administration and the State of California.

This document is entitled *Bakersfield to Palmdale Project Section Revised Draft Environmental Impact Report/Supplemental Draft Environmental Impact Statement* (referred to below as the "Revised Draft EIR/Supplemental Draft EIS").

The Bakersfield to Palmdale Project Section Revised Draft EIR/Supplemental Draft EIS will be available to the public on February 26, 2021.

The Bakersfield to Palmdale Project Section Revised Draft EIR/Supplemental Draft EIS is available online in PDF at the Authority's website (www.hsr.ca.gov) or you can request an electronic copy by calling (866) 300-3044.

Following the Authority's publication of the Draft EIR/EIS in February 2020, the Authority learned that the California Fish and Game Commission advanced the Southern California and Central Coast mountain lion (*Puma concolor*) populations to candidacy for listing under the California Endangered Species Act. The Authority also learned that the U.S. Fish and Wildlife Service (USFWS) determined that listing the monarch butterfly (*Danaus plexippus*) under the federal Endangered Species Act is warranted, but that listing is precluded by other priorities; therefore, the monarch butterfly is now a candidate species under the Endangered Species Act. The U.S. Fish and Wildlife Service will review the species' status annually until a listing decision is made.

Both CEQA and NEPA provide guidance on the recirculation and supplementation of published environmental documents. Pursuant to pertinent requirements of both laws, the Authority, as lead CEQA and NEPA agency for the Bakersfield to Palmdale Project Section, is issuing this Revised Draft EIR/Supplemental Draft EIS limited to the portions of the Draft EIR/EIS to address new information about the mountain lion and the monarch butterfly. New information includes background information, impact analysis, and mitigation measures. In addition to providing new information about the mountain lion and monarch butterfly, the Authority has identified two new mitigation measures to address impacts to wildlife resulting from lighting during construction and during project operation.

Other information that has not been revised, including the methods for evaluating impacts under NEPA and the methods for determining significance under CEQA, as well as the appendices and technical reports, can be found in

the Draft EIR/EIS. The previously published Draft EIR/EIS, including Sections 3.7 and 3.19, is available on the Authority's website (www.hsr.ca.gov). The sections comprising the Revised Draft EIR/Supplemental Draft EIS are:

The Authority reviewed other sections of the Draft EIR/EIS and found, based on research and a review of the evidence, that no other substantive changes would be required. All revisions made in response to the updated information are being made in this Revised Draft EIR/Supplemental Draft EIS. All other subsections and appendices to Section 3.7 and the technical reports supporting Section 3.7 of the Draft EIR/EIS were not revised.

Section 3.7 includes new mitigation measures. These will be incorporated into the Mitigation Monitoring and Enforcement Plan to be included as part of the CEQA/NEPA decision documents.

HAZARDOUS WASTE SITES

As previously noticed in the February 2020 Notice of Availability for the Bakersfield to Palmdale Project Section Draft EIR/EIS, the Bakersfield to Palmdale Build Alternatives would cross one parcel that includes a site on hazardous waste lists enumerated under Section 65962.5 of the California Government Code. This site is Air Force Plant 42 (US Air Force Installation Restoration Program (IRP) Site SS008 – Fuel Transfer Area, Air Force Plant 42, Palmdale, CA).

PUBLIC REVIEW AND COMMENT PERIOD

The Authority Board will consider whether to certify the Final EIR and approve the preferred alternative pursuant to CEQA. The Authority, as NEPA lead agency, will also consider whether to issue a Record of Decision approving the preferred alternative, which best serves the purpose and need for the Bakersfield to Palmdale Project Section and minimizes economic, social, and environmental impacts.
