

10 FINAL EIR/EIS DISTRIBUTION

Since publication of the Burbank to Los Angeles Section Draft Environmental Impact Report/ Environmental Impact Statement (EIR/EIS), this chapter has been revised to reflect notice and distribution of the Final EIR/EIS, to mention the potential effect COVID-19 pandemic precautions on distribution, and to reflect changes in elected officials.

The distribution of the Burbank to Los Angeles Project Section Final EIR/EIS emphasizes the use of electronic media to ensure cost-effective, broad availability to the public and interested parties. The Final EIR/EIS (Volume 1), technical appendices (Volume 2), and alignment plans (Volume 3) are available on the California High-Speed Rail Authority's website (www.hsr.ca.gov). Electronic copies of the Final EIR/EIS (all volumes) and supporting technical reports are available upon request at no cost to the public at the office of the California High-Speed Rail Authority (700 L Street, Suite 800, Sacramento, CA 95814), its Southern California Regional Office (355 S Grand Avenue, Suite 2050, Los Angeles, CA 90071), or by mail. Paper copies of the Final EIR/EIS (all volumes) and electronic copies of the supporting technical reports are available at the California High-Speed Rail Authority's offices. Paper copies of the Final EIR/EIS (Volume 1) also may be reviewed at the libraries listed in Section 10.1, Repository Locations, and electronic copies of the supporting technical reports are available through the library computers (open days/hours may be reduced for compliance with coronavirus public health and safety directives).

All persons, agencies, and organizations listed in this chapter have been mailed the Notice of Availability to inform them of the availability of the Final EIR/EIS. Notice of availability of the Final EIR/EIS has been included in the Federal Register in compliance with the National Environmental Policy Act. Repositories and the cooperating federal agencies were sent copies of the Final EIR/EIS (all volumes) in compliance with the California Environmental Quality Act and the National Environmental Policy Act. Electronic copies were filed with the California State Clearinghouse in compliance with the California Environmental Quality Act and California High-Speed Rail Authority policy and through the e-NEPA electronic filing system in compliance with the National Environmental Policy Act. All Draft EIR/EIS commenters, at a minimum, were mailed written notification of the availability of the Final EIR/EIS (see Volume 4, Responses to Comments on the Draft EIR/EIS, for the list of all commenters). The Executive Summary has been published in English, Arabic, Armenian, Chinese, Japanese, Korean, Spanish, Tagalog, and Vietnamese, the primary languages spoken by residents of the Burbank to Los Angeles area. In addition to the persons, agencies, and organizations listed in this chapter, additional local elected officials, agency representatives, and all others on the project mailing list have been mailed a notification that includes information on how to access the Final EIR/EIS. In light of the COVID-19 pandemic, all notification materials advise the public to refer to the Authority's website for the latest information regarding availability of the document and of consideration of this document at an upcoming Authority Board meeting.
