




Figure B-2 Hourly Summary of Noise Levels Measured at N01 on February 14, 2017






Figure B-3 Hourly Summary of Noise Levels Measured at N01 on February 15, 2017





Figure B-4 Hourly Summary of Noise Levels Measured at N01 on February 16, 2017




Figure B-6 Hourly Summary of Noise Levels Measured at N02 on February 14, 2017






Figure B-7 Hourly Summary of Noise Levels Measured at N02 on February 15, 2017




Figure B-8 Hourly Summary of Noise Levels Measured at N02 on February 16, 2017






Figure B-9 Hourly Summary of Noise Levels Measured at N03 on November 6 and 9, 2009






Figure B-10 Hourly Summary of Noise Levels Measured at N03 on November 9 and 10, 2009






Figure B-11 Hourly Summary of Noise Levels Measured at N04 on November 30 to December 1, 2009






Figure B-12 Hourly Summary of Noise Levels Measured at N04 on December 1 and 2, 2009






Figure B-13 Hourly Summary of Noise Levels Measured at N05 on November 6 and 9, 2009






Figure B-14 Hourly Summary of Noise Levels Measured at N05 on November 9 and 10, 2009






Figure B-15 Hourly Summary of Noise Levels Measured at N06 on May 26, 2016




Figure B-16 Hourly Summary of Noise Levels Measured at N06 on May 27, 2016






Figure B-17 Hourly Summary of Noise Levels Measured at N06 on May 30, 2016




Figure B-18 Hourly Summary of Noise Levels Measured at N06 on May 31, 2016






Figure B-19 Hourly Summary of Noise Levels Measured at N07 on June 14 and 15, 2010




Figure B-20 Hourly Summary of Noise Levels Measured at N08 on November 6 and 9, 2009






Figure B-21 Hourly Summary of Noise Levels Measured at N08 on November 6 and 9, 2009






Figure B-22 Hourly Summary of Noise Levels Measured at N09 on May 26, 2016







Figure B-23 Hourly Summary of Noise Levels Measured at N09 on May 27, 2016






Figure B-26 Hourly Summary of Noise Levels Measured at N10 on May 26, 2016






Figure B-27 Hourly Summary of Noise Levels Measured at N10 on May 27, 2016




Figure B-28 Hourly Summary of Noise Levels Measured at N10 on May 30, 2016






Figure B-29 Hourly Summary of Noise Levels Measured at N10 on May 31, 2016






Figure B-30 Hourly Summary of Noise Levels Measured at N11 on May 26, 2016








### Figure B-31 Hourly Summary of Noise Levels Measured at N11 on May 27, 2016







Figure B-34 Hourly Summary of Noise Levels Measured at N12 on May 26, 2016




Figure B-36 Hourly Summary of Noise Levels Measured at N12 on May 30, 2016






Figure B-37 Hourly Summary of Noise Levels Measured at N12 on May 31, 2016





Figure B-38 Hourly Summary of Noise Levels Measured at N13 on May 31, 2016




Figure B-40 Hourly Summary of Noise Levels Measured at N13 on June 2, 2016






Figure B-41 Hourly Summary of Noise Levels Measured at N14 on November 3 and 4, 2010








Figure B-42 Hourly Summary of Noise Levels Measured at N14 on November 4 and 5, 2010

#### Figure B-44 Hourly Summary of Noise Levels Measured at N15 on March 10 and 11, 2010






Figure B-45 Hourly Summary of Noise Levels Measured at N16 on November 3 and 4, 2010






Figure B-46 Hourly Summary of Noise Levels Measured at N16 on November 4 and 5, 2010






Figure B-47 Hourly Summary of Noise Levels Measured at N17 on May 31, 2016




Figure B-48 Hourly Summary of Noise Levels Measured at N17 on June 1, 2016






Figure B-49 Hourly Summary of Noise Levels Measured at N17 on June 2, 2016




Figure B-50 Hourly Summary of Noise Levels Measured at N18 on May 20, 2013




Figure B-51 Hourly Summary of Noise Levels Measured at N18 on May 21, 2013




Figure B-52 Hourly Summary of Noise Levels Measured at N18 on May 22, 2013






Figure B-53 Hourly Summary of Noise Levels Measured at N18 on May 23, 2013




Figure B-54 Hourly Summary of Noise Levels Measured at N18 on May 24, 2013




Figure B-55 Hourly Summary of Noise Levels Measured at N19 on November 3 and 4, 2010







Figure B-56 Hourly Summary of Noise Levels Measured at N19 on November 4 and 5, 2010





Figure B-58 Hourly Summary of Noise Levels Measured at N20 on June 1, 2016






## Figure B-59 Hourly Summary of Noise Levels Measured at N20 on June 2, 2016







Figure B-62 Hourly Summary of Noise Levels Measured at N22 on May 31, 2016





Figure B-64 Hourly Summary of Noise Levels Measured at N22 on June 2, 2016






# Figure B-65 Hourly Summary of Noise Levels Measured at N23 on March 9 and 10, 2010




Figure B-67 Hourly Summary of Noise Levels Measured at N24 on November 3 and 4, 2010




Figure B-68 Hourly Summary of Noise Levels Measured at N24 on November 4 and 5, 2010






Figure B-69 Hourly Summary of Noise Levels Measured at N25 on May 20, 2013




Figure B-70 Hourly Summary of Noise Levels Measured at N25 on May 21, 2013





Figure B-71 Hourly Summary of Noise Levels Measured at N25 on May 22, 2013




Figure B-73 Hourly Summary of Noise Levels Measured at N25 on May 24, 2013





Figure B-74 Hourly Summary of Noise Levels Measured at N26 on June 1, 2016




Figure B-76 Hourly Summary of Noise Levels Measured at N26 on June 3, 2016







Figure B-77 Hourly Summary of Noise Levels Measured at N27 on March 9 and 10, 2010





Figure B-79 Hourly Summary of Noise Levels Measured at N28 on March 9 and 10, 2010

### Figure B-80 Hourly Summary of Noise Levels Measured at N28 on March 10 and 11, 2010






Figure B-81 Hourly Summary of Noise Levels Measured at N29 on May 20, 2013




Figure B-82 Hourly Summary of Noise Levels Measured at N29 on May 21, 2013






Figure B-83 Hourly Summary of Noise Levels Measured at N29 on May 22, 2013





Figure B-84 Hourly Summary of Noise Levels Measured at N29 on May 23, 2013




Figure B-86 Hourly Summary of Noise Levels Measured at N30 on June 1, 2016






Figure B-87 Hourly Summary of Noise Levels Measured at N30 on June 2, 2016




Figure B-88 Hourly Summary of Noise Levels Measured at N30 on June 3, 2016






Figure B-89 Hourly Summary of Noise Levels Measured at N31 on February 9 and 10, 2010




Figure B-90 Hourly Summary of Noise Levels Measured at N31 on February 10 and 11, 2010






Figure B-91 Hourly Summary of Noise Levels Measured at N32 on October 30 and November 2, 2010







Figure B-92 Hourly Summary of Noise Levels Measured at N32 on November 2 and 3, 2010





Figure B-94 Hourly Summary of Noise Levels Measured at N33 on February 14, 2017





Figure B-96 Hourly Summary of Noise Levels Measured at N33 on February 16, 2017





Figure B-98 Hourly Summary of Noise Levels Measured at N34 on February 14, 2017




Figure B-100 Hourly Summary of Noise Levels Measured at N34 on February 16, 2017






Figure B-101 Hourly Summary of Noise Levels Measured at N35 on May 20, 2013




Figure B-102 Hourly Summary of Noise Levels Measured at N35 on May 21, 2013





Figure B-103 Hourly Summary of Noise Levels Measured at N35 on May 22, 2013






Figure B-105 Hourly Summary of Noise Levels Measured at N35 on May 24, 2013






Figure B-108 Hourly Summary of Noise Levels Measured at N37 on June 1, 2016





Figure B-109 Hourly Summary of Noise Levels Measured at N37 on June 2, 2016

## Figure B-110 Hourly Summary of Noise Levels Measured at N37 on June 3, 2016








Figure B-111 Hourly Summary of Noise Levels Measured at N38 on October 30 and November 2, 2010












Figure B-113 Hourly Summary of Noise Levels Measured at N39 on June 1, 2016




Figure B-114 Hourly Summary of Noise Levels Measured at N39 on June 2, 2016







Figure B-115 Hourly Summary of Noise Levels Measured at N39 on June 3, 2016




Figure B-117 Hourly Summary of Noise Levels Measured at N40 on October 28 and 29, 2009






Figure B-118 Hourly Summary of Noise Levels Measured at N41 on May 20, 2013




Figure B-119 Hourly Summary of Noise Levels Measured at N41 on May 21, 2013






Figure B-120 Hourly Summary of Noise Levels Measured at N41 on May 22, 2013




Figure B-121 Hourly Summary of Noise Levels Measured at N41 on May 23, 2013




Figure B-122 Hourly Summary of Noise Levels Measured at N41 on May 24, 2013





Figure B-123 Hourly Summary of Noise Levels Measured at N42 on June 2, 2016

## Figure B-124 Hourly Summary of Noise Levels Measured at N42 on June 3, 2016






Figure B-125 Hourly Summary of Noise Levels Measured at N42 on June 6, 2016




Figure B-126 Hourly Summary of Noise Levels Measured at N43 on June 2, 2016






Figure B-127 Hourly Summary of Noise Levels Measured at N43 on June 3, 2016





Figure B-128 Hourly Summary of Noise Levels Measured at N43 on June 6, 2016





## Figure B-129 Hourly Summary of Noise Levels Measured at N44 on March 9 and 10, 2010






Figure B-130 Hourly Summary of Noise Levels Measured at N44 on March 10 and 11, 2010






Figure B-131 Hourly Summary of Noise Levels Measured at N45 on October 27 and 28, 2010






Figure B-132 Hourly Summary of Noise Levels Measured at N45 on October 28 and 29, 2010







Figure B-133 Hourly Summary of Noise Levels Measured at N45 on October 29 and 30, 2010












Figure B-135 Hourly Summary of Noise Levels Measured at N46 on October 28 and 29, 2010






Figure B-136 Hourly Summary of Noise Levels Measured at N47 on June 2, 2016






Figure B-137 Hourly Summary of Noise Levels Measured at N47 on June 3, 2016




Figure B-138 Hourly Summary of Noise Levels Measured at N47 on June 6, 2016






Figure B-139 Hourly Summary of Noise Levels Measured at N48 on May 20, 2013




Figure B-140 Hourly Summary of Noise Levels Measured at N48 on May 21, 2013




Figure B-141 Hourly Summary of Noise Levels Measured at N48 on May 22, 2013




Figure B-142 Hourly Summary of Noise Levels Measured at N48 on May 23, 2013




Figure B-143 Hourly Summary of Noise Levels Measured at N48 on May 24, 2013





Figure B-144 Hourly Summary of Noise Levels Measured at N49 on June 2, 2016





Figure B-146 Hourly Summary of Noise Levels Measured at N49 on June 6, 2016




Figure B-148 Hourly Summary of Noise Levels Measured at N50 on June 6, 2016







Figure B-149 Hourly Summary of Noise Levels Measured at N50 on June 7, 2016






Figure B-151 Hourly Summary of Noise Levels Measured at N51 on October 26 and 27, 2010





Figure B-154 Hourly Summary of Noise Levels Measured at N53 on March 5, 2010

#### Figure B-155 Hourly Summary of Noise Levels Measured at N53 on March 8, 2010






Figure B-156 Hourly Summary of Noise Levels Measured at N54 on October 23 and 26, 2010






Figure B-157 Hourly Summary of Noise Levels Measured at N54 on October 26 and 27, 2010






Figure B-158 Hourly Summary of Noise Levels Measured at N55 on June 3, 2016






Figure B-159 Hourly Summary of Noise Levels Measured at N55 on June 6, 2016




Figure B-160 Hourly Summary of Noise Levels Measured at N55 on June 7, 2016






Figure B-161 Hourly Summary of Noise Levels Measured at N56 on March 5, 2010




Figure B-162 Hourly Summary of Noise Levels Measured at N56 on March 5, 2010




Figure B-163 Hourly Summary of Noise Levels Measured at N57 on March 5, 2010








Figure B-164 Hourly Summary of Noise Levels Measured at N57 on March 8, 2010


















#### Figure B-167 Hourly Summary of Noise Levels Measured at N59 on May 20, 2013






Figure B-168 Hourly Summary of Noise Levels Measured at N59 on May 21, 2013




Figure B-169 Hourly Summary of Noise Levels Measured at N59 on May 22, 2013




Figure B-170 Hourly Summary of Noise Levels Measured at N59 on May 23, 2013





Figure B-171 Hourly Summary of Noise Levels Measured at N59 on May 24, 2013



### Figure B-172 Hourly Summary of Noise Levels Measured at N60 on June 3, 2016






# Figure B-173 Hourly Summary of Noise Levels Measured at N60 on June 6, 2016






#### Figure B-174 Hourly Summary of Noise Levels Measured at N60 on June 7, 2016






#### Figure B-175 Hourly Summary of Noise Levels Measured at N61 on June 3, 2016

#### Figure B-176 Hourly Summary of Noise Levels Measured at N61 on June 6, 2016







Figure B-177 Hourly Summary of Noise Levels Measured at N61 on June 7, 2016






Figure B-180 Hourly Summary of Noise Levels Measured at N63 on May 20, 2013




Figure B-181 Hourly Summary of Noise Levels Measured at N63 on May 21, 2013




Figure B-182 Hourly Summary of Noise Levels Measured at N63 on May 22, 2013




Figure B-183 Hourly Summary of Noise Levels Measured at N63 on May 23, 2013





Figure B-184 Hourly Summary of Noise Levels Measured at N63 on May 24, 2013






# Figure B-185 Hourly Summary of Noise Levels Measured at N64 on March 9, 2010




#### Figure B-186 Hourly Summary of Noise Levels Measured at N64 on March 10, 2010






#### Figure B-187 Hourly Summary of Noise Levels Measured at N65 on June 6, 2016




#### Figure B-188 Hourly Summary of Noise Levels Measured at N65 on June 7, 2016






#### Figure B-189 Hourly Summary of Noise Levels Measured at N65 on June 8, 2016





### Figure B-190 Hourly Summary of Noise Levels Measured at N66 on June 6, 2016






# Figure B-191 Hourly Summary of Noise Levels Measured at N66 on June 7, 2016




#### Figure B-192 Hourly Summary of Noise Levels Measured at N66 on June 8, 2016














# Figure B-195 Hourly Summary of Noise Levels Measured at N68 on March 5, 2010



# Figure B-196 Hourly Summary of Noise Levels Measured at N68 on March 8, 2010




#### Figure B-199 Hourly Summary of Noise Levels Measured at N70 on June 6, 2016





### Figure B-200 Hourly Summary of Noise Levels Measured at N70 on June 7, 2016






#### Figure B-201 Hourly Summary of Noise Levels Measured at N70 on June 8, 2016



#### Figure B-202 Hourly Summary of Noise Levels Measured at N71 on February 5, 2010






# Figure B-203 Hourly Summary of Noise Levels Measured at N71 on February 8, 2010




# Figure B-204 Hourly Summary of Noise Levels Measured at N72 on October 15 and 16, 2010




Figure B-207 Hourly Summary of Noise Levels Measured at N73 on May 21, 2013




Figure B-208 Hourly Summary of Noise Levels Measured at N73 on May 22, 2013




Figure B-209 Hourly Summary of Noise Levels Measured at N73 on May 23, 2013






Figure B-210 Hourly Summary of Noise Levels Measured at N73 on May 24, 2013





Figure B-211 Hourly Summary of Noise Levels Measured at N74 on October 15 and 16, 2010








#### Figure B-213 Hourly Summary of Noise Levels Measured at N75 on March 5, 2010
