

9 PUBLIC AND AGENCY INVOLVEMENT

Since publication of the Draft Environmental Impact Report/Environmental Impact Statement (EIR/EIS), the following substantive changes have been made to this chapter:

- Updated the introductory discussion of this chapter to include a footnote on the recently signed U.S. Executive Order (USEO) 14096.
- Updated Section 9.4.4, Tribal Coordination Meetings, and Table 9-5, Public and Agency Meetings, to reflect that the San Manuel Band of Mission Indians is now known as Yuhaaviatam of San Manuel Nation.
- Updated Section 9.4.5, Agency Meetings and Consultation, to revise the list of Responsible Agencies under CEQA, consistent the list of CEQA Responsible Agencies in Chapter 1, Project Purpose, Need, and Objectives, and Chapter 2, Alternatives, of this Final EIR/EIS.
- Updated Section 9.4.7, Section 404 Process, Clean Water Act, to provide additional details of the coordination between the Authority, U.S. Army Corps of Engineers (USACE), and U.S. Environmental Protection Agency (USEPA), since the publication of the Draft EIR/EIS.
- Updated Section 9.4.7, Section 7 Consultation, Federal Endangered Species Act, to identify
 that the Authority has submitted a Draft Biological Assessment to the U.S. Fish and Wildlife
 Service (USFWS) after the publication of the Draft EIR/EIS.
- Drafted Section 9.6, Publication and Review of the Draft EIR/EIS to provide details regarding environmental document publication; public and agency information meetings and hearings; comments on the Draft EIR/EIS; responses to common comments; and engineering and design refinements after publication of the Draft EIR/EIS.
- Updated Section 9.7, Log of Public and Agency Meetings, to account for additional meetings with the public, agencies, and stakeholders.

Pursuant to the requirements of the National Environmental Policy Act (NEPA) and the California Environmental Quality Act (CEQA), the California High-Speed Rail Authority (Authority), as lead agency, has implemented a public and agency outreach program as part of the environmental review process. This chapter is generally organized chronologically, following the iterative alternative development and consideration process outlined in Section 2.5, Potential Alternatives Considered during Alternatives Screening Process. This chapter summarizes the public scoping process through the release of this Palmdale to Burbank Project Section Final EIR/EIS.

The public and agency involvement program includes the following key efforts:

- Public Involvement and Outreach—Informational materials, including fact sheets;
 informational and scoping meetings, including town hall meetings, public and agency scoping meetings, meetings with individuals and groups, and presentations; and media briefings
- Agency Involvement—Agency scoping meetings, interagency working group, meetings with agency representatives, and other agency consultations
- Tribal Involvement—Meetings with tribal representatives, informational materials, including specific fact sheets on involvement and monitoring
- Publication—Notification and circulation of the Draft EIR/EIS
- Informational Meetings and Hearings—Conducting informational meetings and hearings following release of the Draft EIR/EIS

The Authority posts meeting notices and public documents on its website, www.hsr.ca.gov. The website includes information about the California High-Speed Rail (HSR) System and the proposed route. It also houses the Authority's most recent biennial business plan, newsletters, press releases, Authority Board of Directors meeting summaries, recent developments in the design process of the project, status of the environmental review process, Authority contact



information, and related links. Authority meetings are open to the public, and one of the first items on each meeting agenda offers an opportunity for public comments, questions, and discussion.

The Authority posted the Draft EIR/EIS and technical appendices on its website. Materials on how to participate in the public comment period and how to navigate the document were also available online. Published notification materials include contact information in Arabic, Armenian, and Spanish. In addition, there was contact information for additional translation assistance in 33 other different languages.

Public and agency scoping conducted for the Palmdale to Burbank Project Section involved stakeholder and agency coordination as listed at the end of this chapter in Table 9-5. The scoping occurred from July 24, 2014, to December 14, 2014. While the Draft EIR/EIS was being prepared, the Authority held more than 240 individual and group meetings in the Palmdale to Burbank Project Section area. Frequently asked questions concerned impacts on property, sensitive plant and animal habitat, water and groundwater, community character, air quality, noise and vibration, traffic circulation, the alignment alternatives, station locations, environmental justice (EJ), and impacts on communities. Other concerns had to do with impacts of other alternatives not pursued and the status of changes that individuals and organizations had suggested. When possible, project staff answered these and other questions, but often the response was to refer them to the environmental analysis in the Draft EIR/EIS. This included mention of opportunities for public comment on the document.

Because NEPA and CEQA require the environmental review process to consider public comments, these comments informed the preparation of the Draft EIR/EIS. This includes suggestions from individuals and organizations about the alternatives. When received, questions that could not be answered at public meetings were logged and HSR staff followed up with individuals and organizations; otherwise, items were noted for discussion at future public meetings as more specific information became available. Table 9-5, presented at the end of this chapter provides a comprehensive list of all meetings held as part of the Authority's public outreach for the Draft EIR/EIS.

Following the direction of U.S. Executive Order (USEO) 12898, ¹ and the U.S. Department of Transportation (USDOT) Order 5610.2C, the Authority promotes EJ Guidance into its programs, policies, and activities to avoid, minimize, or mitigate disproportionately high and adverse human health and environmental effects, including social and economic effects on minority and/or low-income populations. The Authority emphasizes the fair treatment and meaningful involvement of people regardless of race, color, national origin, and income levels, from the early stages of project planning through design, construction, operations, and maintenance (USEO 12898 and USDOT Order 5610.2C are further discussed in Section 9.1).

The Authority conducted specific outreach efforts to low-income and minority populations. The purpose of this outreach was to increase the Authority's understanding of project effects on these populations. EJ populations were identified using the following data from the U.S. Census Bureau: 2010 U.S. Census data, American Community Survey (ACS) 2009–2013 data for Palmdale, and ACS 2010–2014 data for the Central and Burbank Subsections. The *Palmdale to Burbank Project Section: Community Impact Assessment* (Authority 2019) contains a list of EJ-related interest groups that have been engaged through outreach efforts.²

The following sections describe the project's EJ outreach, public and agency scoping, alternatives analysis process, the additional outreach during the development of the Draft EIR/EIS, and the

EO 14096—Revitalizing Our Nation's Commitment to Environmental Justice for All was enacted on April 21, 2023. EO 14096 on environmental justice does not rescind EO 12898, which has been in effect since February 11, 1994, and is currently implemented through DOT Order 5610.2C. This implementation will continue until further USDOT guidance is provided regarding the implementation of the new EO 14096 on environmental justice.

It is important to note that the Palmdale to Burbank Project Section traverses the Northeast San Fernando Valley, where nearly all communities are designated as EJ communities due to high levels of linguistic isolation and poverty. Refer to Chapter 5, Environmental Justice, for more information regarding these communities.



notification and circulation of this document. A complete log of the outreach activities is presented in Table 9-5 at the end of this chapter.

9.1 Environmental Justice Outreach

EJ is a topic rooted in Title VI of the Civil Rights Act of 1964, which prohibits discrimination on the basis of race, color, and national origin, including the denial of meaningful access for limited English proficiency persons, in programs and activities receiving federal financial assistance. Per the direction of USEO 12898, federal agencies developed guidelines to foster equitable outcomes for low-income and minority populations. The USDOT Actions to Address Environmental Justice in Minority Populations and Low-Income Populations (USDOT Order 5610.2C)

Environmental Justice

Environmental justice addresses the United States Department of Transportation's goals to address the fair treatment and meaningful involvement of all people, regardless of race, color, national origin, or income, with respect to the development, implementation, and enforcement of environmental laws, regulations, and policies.

applies to actions undertaken by the USDOT operating administrations, including the Federal Railroad Administration (FRA), to implement USEO 12898, affirming the importance of considering EJ principles as part of early planning activities to avoid disproportionately high and adverse effects. The methodology used to identify low-income populations and minority populations also incorporates guidance from the Council on Environmental Quality, which has oversight of the federal government's compliance with USEO 12898 and NEPA (Council on Environmental Quality 1997) (for more information, refer to Chapter 5, Environmental Justice).

All the Authority's outreach efforts have been mindful of the need for an inclusive, sensitive approach. This has been accomplished through a range of efforts, starting with bilingual English-Spanish meeting flyers that also included information about how to access the meetings in additional languages. Legal notices and newspaper advertisements were published in ethnic media and are listed in Table 9-1.

All meeting notices and presentations were translated into Spanish due to the presence of large numbers of Spanish speakers in the region. Spanish interpreters and/or bilingual staff were available at all public meetings. In addition, interpreters were available at meetings in areas where at least 5 percent of residents used a specific language other than English. These included Japanese, Armenian, Eastern Armenian, Korean, Tagalog, Thai, Mandarin Chinese, and Vietnamese. Table 9-2 lists the meetings that included language interpreters.

On an ongoing basis, but particularly leading up to every series of meetings (especially the scoping meetings), the Authority conducted extensive outreach to elected offices, cities, and neighborhood councils to relay important information to their constituents, including those in EJ communities. This outreach occurred in advance of planned meetings and included briefings, mailings, and social media toolkits.

The Authority hosted Community Working Groups (CWG) in 2015 and 2016 in EJ communities, including Sylmar, San Fernando, Pacoima, Sun Valley, Sunland, and Acton with Spanish interpreters (see Table 9-5 for meeting listings). In addition to Neighborhood Council representatives from these areas, participants at these meetings included representatives of the organizations listed below. Because of the prevalence of the Spanish language in the region, ethnic community organizations participating in these meetings were mainly Spanish-language ethnic groups:

9.2 Public and Agency Scoping

Public and agency scoping is an important element in the process of determining the focus and content of an EIR/EIS. It provides an opportunity for public involvement and helps identify the range of actions, alternatives, environmental effects, and mitigation measures to be analyzed. Public and agency scoping helps focus detailed study on those issues pertinent to the final decision of the proposed Palmdale to Burbank Project Section Build Alternatives and certification of the Final EIR/EIS. As described below, the Authority conducted scoping meetings for the Palmdale to Burbank Project Section Draft EIR/EIS in August 2014 and additional outreach in December 2014.

The Palmdale to Burbank Project Section Draft EIR/EIS evolved from preliminary analysis of the Palmdale to Los Angeles Section, which had been identified in the *Final Program EIR/EIS for the Proposed California High-Speed Train System* (Authority and FRA 2005). In February 2007, the



Authority and FRA began a project-level environmental review of the Palmdale to Los Angeles Project Section, proceeding with formal scoping meetings between March and April 2007. Due to the relatively wide expanse of the original corridor, which included both the State Route (SR) 14 freeway and Union Pacific Railroad alignments between the Antelope Valley and Santa Clarita, the Authority proposed to divide the corridor into two project sections; Palmdale to Burbank and Burbank to Los Angeles. Separate Notices of Preparation (NOP) and Notices of Intent (NOI) were issued for each of these proposed project sections in 2014. The design of the new project sections considered public input received during the scoping process for the Palmdale to Los Angeles Section.

9.2.1 Notices of Preparation, Notices of Intent, and Public Information **Materials**

The Authority issued a NOP (State Clearinghouse number 2014071074) on July 24, 2014, initiating public scoping for the Palmdale to Burbank Project Section Draft EIR/EIS. The NOP was distributed to the State Clearinghouse, elected officials, local, regional, and state agencies, and interested public stakeholders. The FRA published the NOI in the Federal Register on July 24, 2014.

The Authority and FRA encouraged broad participation in the Draft EIR/EIS scoping process, inviting comments and suggestions from all interested agencies and members of the public to ensure identification of the full range of environmental issues related to the project. A comprehensive database containing all comments received during the project development process was kept by the Authority and regularly used during the development of alternatives to facilitate the review of stakeholder issues in conjunction with the review of project objectives and environmental resources.

In the Draft EIR/EIS NOP/NOI, public agencies with jurisdiction over the project were requested to advise the Authority and the FRA of the applicable permit and environmental review requirements of each agency, and the scope of content of the environmental information relevant to the agency's statutory responsibilities in connection with the project.

9.2.2 **Public Scoping Meetings**

The Authority and FRA received comments during scoping meetings held in August 2014 and open house meetings in December 2014.³ As part of public outreach for the Draft EIR/EIS, seven public and agency scoping meetings were held between August 5, 2014, and August 19, 2014, in Santa Clarita, Burbank, Palmdale, Acton/Agua Dulce, Sylmar, Lake View Terrace, and downtown Los Angeles. These meetings introduced the split of the alignment between Bakersfield to Palmdale and Palmdale to Burbank. Seven additional follow-up meetings were conducted between December 2, 2014, and December 14, 2014, in Santa Clarita, Sun Valley, Palmdale, Burbank, San Fernando, Sylmar, and Acton. The additional meetings introduced the potential for alignments to traverse the Angeles National Forest (ANF).

9.2.2.1 August 2014 Meetings

All of the August 2014 public scoping meetings were held between 5:30 p.m. and 7:30 p.m. to maximize attendance. The format of the scoping meetings was an open house, which allowed people to arrive at any time to obtain information and provide input. Agendas for open house meetings, fact sheets, and scoping period comment sheets were distributed at the scoping meetings. The comments received at the meetings are summarized in Section 9.2.4 and in the Palmdale to Burbank Section 2014 Scoping Report (Authority 2014).

More than 80,000 property owners, residents, and business tenants within a designated mailing area⁴ were mailed bilingual English-Spanish notices of the public scoping meetings. The direct mail recipients were members of the public identified as stakeholders, affected property owners, and those who previously attended meetings or submitted comments and questions. Local newspapers (including ethnic media in seven languages other than English) published advertisements of the meetings, and local media outlets received press releases.

An electronic public scoping notice was emailed to more than 5,300 contacts included in the project stakeholder database. The electronic public scoping notice was also featured on the Authority's website and shared with local cities, agencies, elected officials, and key stakeholder groups for posting on their respective websites and to share via their web blasts and social media platforms.

Approximately 916 people participated in the seven public scoping meetings hosted in August 2014. The places and dates of the public and agency scoping meetings are listed below in Table 9-3

In addition to these formal scoping meetings, public input on the scope of the environmental review was sought through other means, including presentations, briefings, and workshops. Briefings were conducted with elected officials, local city officials and neighborhood councils, and local businesses and organizations. Table 9-5 lists the meetings held as part of this outreach effort, in addition to non-scoping meetings. Bilingual English/Spanish comment cards were distributed at meetings with the option to be mailed, email notifications were sent alerting stakeholders of the opening of the public comment period, and a press release was issued to encourage participation and public comments at the public hearings.

9.2.2.2 December 2014 Meetings

Following the August 2014 public scoping meetings, seven additional open house meetings were conducted as follow-up public involvement in December 2014. The purpose of these meetings was to introduce elements of the project, identify alternatives proposed for evaluation, share the project development progress and schedule, and solicit additional public input. The meetings were used to present new information on the Draft EIR/EIS alternative alignments and new proposed alternative alignments through the ANF.

Consistent with the Authority's prior outreach programs to inform and engage stakeholders, a variety of noticing methods were used in advance of the seven December 2014 open house meetings. Methods included mailing of notices in English and Spanish to more than 54,000 separate addresses, including people on the project stakeholder database, and other property owners, residents, and business tenants within a 500-foot buffer around the proposed alternative alignments and within a 0.25-mile buffer around stations.

Flyers for the open house meetings were distributed to offices of representative elected officials, libraries, community centers, city halls, senior centers, and other public facilities. Electronic versions of the flyer were distributed via email to about 6,000 contacts included in the project stakeholder database. Advertisements in local newspapers were published for communities along the Palmdale to Burbank Project Section, including ethnic newspapers reflective of the geographic scope of the project section during this time. Briefings were held in advance of meetings for representative elected officials, cities, and town/neighborhood councils. Stakeholder organizations were notified of the upcoming open house meetings and were asked to help share the meeting information with their constituents. Media coverage also took place during and after the meetings. The comments received at the meetings are summarized in Section 9.2.4 and in the *Palmdale to Burbank Project Section 2014 Scoping Report* (Authority 2014).

Nearly 1,000 people attended the seven December 2014 open house meetings, which were hosted at the locations listed in Table 9-4.

9.2.3 Agency Scoping

In addition to scoping meetings held in 2014, one-on-one follow-up meetings were held with federal agencies to keep them informed of project progress, including the USEPA, USACE, USFWS, and United States Forest Service (USFS). Federal cooperating agencies for the NEPA EIS are the Surface Transportation Board, USACE, USFS, and the Bureau of Land Management. The agency meetings were held during the same period as the December 2014 scoping meetings. More information regarding agency scoping can be found in the *Palmdale to Burbank Project Section 2014 Scoping Report* (Authority 2014).

In September 2019, the Authority invited the Federal Aviation Administration (FAA) to serve as a cooperating agency under NEPA for the Palmdale to Burbank Project Section. Since then, the Authority held meetings with FAA staff in November 2020, January, and April of 2021 to discuss FAA participation as a cooperating agency.

9.2.4 Scoping Comments

The public and agency comments received through the scoping meetings held in August and December of 2014 helped to identify general environmental issues to be addressed in the *Palmdale to Burbank Project Section Draft EIR/EIS*. The comments also identified questions



about the proposed alignments and stations, suggestions for new or modified alignments and stations, and other concerns related to the project.

Throughout the scoping process, the Authority received 928 comment submittals, which contained approximately 5,520 individual comments from agencies, organizations, and individuals. These comment submittals included comment forms submitted at the scoping meetings, comment forms that were mailed in, letters, emails, and telephone calls.

The comments received covered a wide variety of topics. Many commenters inquired about impacts on the mobility of low-income or minority populations. Others wanted to see a full analysis and comparison of short-and long-term impacts on resources between the proposed alternatives in the Draft EIR/EIS. A few commenters requested a description of the proposed HSR alternatives near Hollywood Burbank Airport and expressed concern regarding the proposed alignments complying with Federal Aviation Administration regulations. Commenters also proposed new alignments or alterations to the proposed alignments. Other issues mentioned in scoping comments included the following:

- · Air quality and global climate change impacts
- · Use of clean, renewable electricity
- Impacts on domestic and wild animals
- · Concerns over impacts on the ANF
- Impacts on parks and other open spaces
- Potential negative effects on archaeological sites
- Concerns regarding project impacts on growth and communities
- Impacts on community character
- Identification of electromagnetic interference/fields impacts
- Impacts on biological resources and wetlands
- Impacts of tunneling on hydrology
- · Impacts on oil fields and wells
- Negative visual impacts
- Noise and vibration evaluations impacts
- Responses to the NOP/NOI
- Risk of seismic activities
- Safety and security issues
- Station area access issues
- Station relocation
- Using existing travel routes, causing roadway impacts during construction

9.3 Alternatives Analysis Process

Between 2010 and 2016, the Authority completed six alternative analysis reports that initially addressed the Palmdale to Los Angeles Project Section and later the Palmdale to Burbank Project Section. During the alternatives analysis process, the Authority continued ongoing efforts to engage the public and public agencies. Outreach to the public involved at-large public meetings and CWGs. Outreach to public agencies involved meetings with federal and state agencies, including the USEPA, USACE, the California State Water Resources Control Board, and the California Air Resources Board.

The alternative analysis reports provided information to the public regarding the alternatives analysis process, the initial range of alternatives considered, and the criteria for evaluating those alternatives. The purpose of this process was to identify a reasonable range of alternatives for detailed study by defining feasible station and alignment configurations that would meet the HSR project purpose and the objectives of stakeholder agencies. Public information meetings were held during the alternatives analysis process to inform the public about the Draft EIR/EIS alternative recommendations.



9.3.1 Scoping and Identifying Potential Alternative Alignments

As mentioned in Section 9.2.2.1, the Authority initiated project-level environmental review and formal scoping meetings, ultimately completing the *Palmdale to Los Angeles Section EIR/EIS Scoping Report* in June 2007. Following the publication of the scoping report, the Authority prepared four Supplemental Alternative Analyses (SAA):

- The July 2010 Preliminary Alternative Analysis assessed the Palmdale to Los Angeles
 Project Section and evaluated potential alternatives, platform locations, and design options
 for Los Angles Union Station (LAUS)
- The March 2011 SAA reevaluated the Palmdale to Los Angeles Section Project from Sylmar to LAUS
- The April 2012 SAA focused solely on the Palmdale to Sylmar area
- The May 2014 SAA reevaluated all proposed alternatives and station options

After the May 2014 SAA, the Authority proposed to divide the corridor into two project sections: Palmdale to Burbank and Burbank to Los Angeles. This action to divide the corridor was due to the wide expanse of the corridor that included both the SR 14 freeway and Union Pacific Railroad alignments between the Antelope Valley and Santa Clarita. New NOPs and NOIs were issued for each of the new proposed project sections on July 24, 2014.

9.3.1.1 Palmdale to Burbank Project Section

Subsequent to splitting the corridor into the Palmdale to Burbank and Burbank to Los Angeles Project Sections, two SAAs were prepared between 2015 and 2016.

- The June 2015 SAA introduced refinements to rail alignments along the SR 14 corridor as well as several East Corridor alignments⁵
- The April 2016 SAA evaluated additional refinements to rail alignments and HSR station alternatives

These two studies refined the potential alignment alternatives, Maintenance Facility sites, and station options, and they considered the public and agency comments received during the August and December 2014 scoping meetings.

The final SAA, the *Palmdale to Burbank Project Section Supplemental Alternatives Analysis* (Authority 2016), made recommendations to eliminate some of alignment alternatives and station options, while identifying the Build Alternatives to be evaluated in this Final EIR/EIS.

The 2016 SAA considered three station options in Burbank: Option A, which featured mostly atgrade and above-grade facilities within the city of Burbank and the Sun Valley community; Option B, which featured both at-grade and underground facilities within the city of Burbank; and Option C, which featured both at-grade and underground facilities aligned in a north-south orientation parallel to North Hollywood Way, within the city of Burbank. The engineering within the Palmdale to Burbank Project Section was advanced sufficiently to make it practical for the proposed Palmdale to Burbank alignment alternatives to connect to either Burbank Airport Station Platform Configuration Option A or Option B. In 2018, the Authority withdrew Option A based on the Burbank Airport Station Option Screening Report (Authority 2018), primarily due to community and potential environmental justice concerns. Option A had the greatest amount of residential and business displacements and noise/vibration and visual impacts, and it also had the worst intermodal connections. Station Option B was carried forward as part of the Build Alternatives, and then further refined to minimize impacts. Option B Refined was designed to locate the platforms closer to the future location of the Hollywood Burbank Airport terminal, reduce the

station depth, improve constructability, reduce commercial and industrial property takes, and eliminate the tunnel length underneath residential neighborhoods to the south.

9.3.2 Public Information Meetings during the Alternatives Analysis Process

As part of the alternatives analysis process, the Authority undertook a comprehensive community and stakeholder engagement program in the Palmdale to Burbank Project Section in 2015 and early 2016. Throughout this period, the Authority gathered feedback regarding the technical aspects of the proposed project alignments and station options, along with general questions regarding the statewide and section-specific alternatives analysis process. Outreach included, but was not limited to, at-large public meetings, CWGs, and briefings. This outreach is described in more detail in the sections that follow. These meetings are listed in Table 9-5 at the end of the chapter.

9.3.2.1 At-Large Public Meetings

The at-large public meetings were community open house meetings held for broad participation in the alternatives analysis process from all corridor communities and members of the public. Various meeting formats, such as open houses, formal presentations, and question and comment sessions, provided opportunities for participant input. These public meetings also included detailed information displays outlining the development and refinement of the proposed alignments. The Authority posted project information and announcements on its website.

9.3.2.2 Community Working Groups

The purpose of the CWGs was to provide a forum for integrating local input into the Draft EIR/EIS alternatives analysis process. The CWGs functioned as focus groups further discussing the feedback generated at the at-large meetings through concentrated discussions with each of the project corridor communities. The CWG participants' role was to represent the interests of a jurisdiction, facility, service, agency, or organization. The CWG was locally oriented in scope and influence in relation to a defined portion of the project corridor. CWGs were not a formal voting body but were organized to enhance local input into the planning process.

Participation in CWG meetings was by invitation through recommendation from the Authority or the management of the jurisdictions, facilities, institutions, agencies, and organizations represented in the project corridor. Research into local community groups and review of Authority meeting attendees who expressed interest in the project also informed creation of CWGs. Each group consisted of approximately 30 members, which allowed the CWGs to remain small enough for constructive discussion. Participants included those who were conversant in specific interests, such as planning, mobility, access, economic development, safety, and security. The typical format for the CWG meetings consisted of a presentation, open discussions, and interactive exercises to gather feedback from participants.

As part of this effort, there was a focus on the EJ communities in the Northeast San Fernando Valley. CWG members provided important insight and feedback from their local communities to the Authority prior to and during the preparation of the SAAs and served as vital partners for disseminating information about the project and public meetings to their constituencies. Two of the CWG meetings in 2015 were conducted entirely in Spanish by bilingual Authority and consultant staff to facilitate involvement and feedback from Spanish speakers.

9.3.2.3 Briefings

In addition to the public information meetings, the Authority hosted one-on-one briefings and small group meetings throughout the alternatives analysis process. This effort provided updates and presentations to clubs, organizations, and business owners within: Los Angeles County; the cities of Santa Clarita, San Fernando, Los Angeles, Burbank, and Palmdale; and to the communities of Acton/Agua Dulce, Sylmar, Lake View Terrace, Pacoima, Sun Valley, and Shadow Hills. The objectives of these meetings included facilitating an inclusive and transparent process.



9.3.2.4 Summary of Feedback

The Authority received comments on a broad range of topics from the at-large public meetings, CWGs, and briefings held during the alternatives analysis process. Common comments included: concern about impacts of proposed alternatives on EJ communities; the use of clean, renewable electricity to operate the project; the HSR route passing through private properties; impacts on community character; and impacts on domestic and wild animals.

9.3.3 Environmental Resource Agency Meetings during the Alternatives Analysis Process

The Authority and the FRA worked closely with federal and state resource agencies on an ongoing basis during the alternatives analysis process.

One-on-one and/or group meetings were held with federal agencies (including USEPA, USACE, USFWS, and USFS) to keep them informed of project progress. In particular, the Authority regularly engaged the USFS regarding NEPA compliance and matters related to the Special Use Authorization process that the Authority would need to engage in to obtain USFS authorization to construct and operate the HSR within the ANF, including areas of the San Gabriel Mountain National Monument (SGMNM). Meetings with USFS covered such topics as the details of the Build Alternatives, methods and approaches regarding tunnel construction, new requirements associated with the designation of parts of the ANF as a national monument, and resources of particular sensitivity including biological, aquatic, and cultural resources. For a more detailed information regarding issues raised by the various agencies please see *Palmdale to Burbank Project Section Supplemental Alternatives Analysis* (Authority 2016).

Additionally, several state agencies were engaged in the alternatives analysis process and worked in conjunction with the Authority to identify and protect resources of concern, such as aquatic resources, threatened endangered species, and potential historic resources. Some of the key state agencies included the following:

- California State Water Resources Control Board
- California Air Resources Board
- California Department of Toxic Substance Control
- California Department of Fish and Wildlife (CDFW)
- California State Historic Preservation Office (SHPO)
- California Department of Transportation

9.3.4 Una Lake Avoidance Alternative Process

Building on the Alternatives Analysis process and consultation with the USACE and the USEPA, the Authority explored additional refinements to the alternatives in 2020 to avoid or minimize impacts on special aquatic resources. In particular, these efforts considered refinements to the alternatives near Una Lake. As a result of this process, the Authority developed the SR14A, E1A, and E2A Build Alternatives. Additional information regarding the discussion of Build Alternatives SR14A, E1A, and E2A can be found in the Checkpoint B Summary Report (Authority 2020a). These new Build Alternatives received agency concurrence letters from USACE and USEPA on July 30, 2020.⁶ For further information regarding the Una Lake Avoidance Alternative process, refer to Chapter 2, Alternatives.

⁶ Checkpoint B considers additional information developed subsequent to programmatic analyses of alternatives. This information is used to inform the selection of a reasonable range of alternatives for consideration in the Tier 2 environmental review. For further discussion of Checkpoint B, see Section 9.4.2.



9.4 Development of the Draft EIR/EIS

Throughout the development of the Draft EIR/EIS, the Authority and FRA continued to hold meetings to consult with federal, state, and local agencies and to provide project updates and obtain additional feedback from the public and stakeholders. The public and agency outreach associated with the Draft EIR/EIS continues to include public discussion of the preferred alternative. The following subsections provide details of these activities.

9.4.1 Outreach, Involvement, and Communications Guidance

Stakeholder Working Groups (SWGs)

SWGs are locally oriented in scope and influence in relation to a defined portion of the corridor. SWGs provide a forum for integrating local input into the Palmdale to Burbank Project Section. The participant's role is to represent the interests of a jurisdiction, facility, service, agency, or organization and to serve as a liaison of these interests.

The Authority and FRA held informal and formal public meetings to help inform the Draft EIR/EIS preparation process. The meetings consisted of open houses, formal presentations, and question-and-answer sessions. Project information and meeting announcements were posted on the Authority's website. Table 9-5 lists the dates of public meetings that occurred during the development of the Draft EIR/EIS since summer of 2016.

9.4.1.1 Open House Meetings

The Palmdale to Burbank open house meetings were a primary platform by which the Authority announced its latest project information to the public-at-large during the development of the Draft EIR/EIS. Alternatives analysis open house meetings were held in September 2016 in Palmdale, Acton/Agua Dulce, and the Northeast San Fernando Valley. Similar to the CWG, the September 2016 alternatives analysis open house meetings were not a formal voting body and were locally oriented to the corridor to enhance local input into the HSR planning process.

The public was informed of the open house meetings and invited to attend through general meeting notices, flyers, and local newspaper advertisements. The format for the alternatives analysis open house meetings included large screen PowerPoint presentations looped at each individual station, a formal 45-minute presentation, and a question-and-answer session. The timeframe was approximately three hours with 50 to 100 attendees per meeting.

The main comment topic highlighted at the open house meeting by participants was to increase the length of tunneling used within the alignment to reduce community impacts and increase land preservation. Another focus among the attendees was environmental issues, such as water wells and water resources, air emissions, and noise pollution.

9.4.1.2 Community and Stakeholder Working Groups

During development of the Draft EIR/EIS, additional CWGs were formed through the same process as the CWGs described in Section 9.2.2.1, Community Working Groups. CWG and SWG meetings and open house meetings were conducted to engage local residents in the project area on an ongoing basis. The Palmdale to Burbank CWG and SWG meetings were held in August 2016. These meetings took place in Sun Valley/Pacoima, Santa Clarita, Acton/Agua Dulce, and northeast San Fernando Valley. The meetings provided a forum for integrating local input to the Draft EIR/EIS.

Participation in the SWG meetings was through recommendation by the Authority. This group encompassed leaders from various constituents near the HSR corridor, including those conversant in land use, transportation, environmental sustainability, and societal topics within the region. Information gathered during these meetings was collected by staff who were present at the meetings.

The input from CWG and SWG participants was far-ranging and specific to their local area. Most were very concerned about experiencing impacts on their community. The main areas of concern addressed by attendees during the CWG and SWG meetings focused on property acquisition



impacts, residential and commercial displacement, effects on property values, equestrian impacts, and preserving land. Another focus among the stakeholders was on environmental topics, such as clean air and reducing waste.

9.4.1.3 Technical Working Group Meetings

Several Technical Working Group meetings were held for the Draft EIR/EIS. For a list of Technical Working Group meetings, see Table 9-5. Additionally, community leaders with technical expertise, including land use, transportation, and environmental sustainability, were included in the SWG meetings, as described in Section 9.4.1.2, Community/Stakeholder Working Groups.

9.4.2 Agreements and Memoranda of Understanding

The Authority has several agreements and memorandum of understandings (MOU) in place for the HSR system that are applicable to the Palmdale to Burbank Project Section. The 2011 MOU for Achieving an Environmentally Sustainable High-Speed Train System for California establishes a framework under which the signatory agencies committed to working together to achieve an environmentally sustainable HSR system, including the Palmdale to Burbank Project Section (Authority 2011a). Signatories include the Authority, FRA, the U.S. Department of Housing and Urban Development, the Federal Transit Administration, and the USEPA. This MOU defines common goals, identifies key areas for collaboration, and defines expectations and terms for signatory agencies. Consistent with the MOU, the Authority recognizes the need to build the project using sustainable methods that accomplish the following goals:

- Promote sustainable housing and development patterns
- Integrate station access and amenities into the fabric of surrounding neighborhoods
- Stimulate multimodal connectivity and increase options for affordable, convenient access to goods, services, and employment
- Reduce passenger transportation emissions across California, thereby reducing associated environmental and health impacts
- Promote energy efficiency and renewable energy
- Encourage best practices for water efficiency and conservation
- Protect ecologically sensitive and agricultural lands

9.4.3 Public Information Materials and Meetings

The Authority hosted public information meetings during preparation of the EIR/EIS to inform the public about the alternatives analysis recommendations for the Palmdale to Burbank Project Section and the status of the Draft EIR/EIS preparation. In addition, these meetings provided information on various HSR project components and served as forums for obtaining feedback. The public information meetings included presentations and project information materials (on display and in fact sheets). Meetings were announced through direct mail to those on the project mailing database, advertisements in local newspapers, and postings on the Authority's website (www.hsr.ca.gov). Various publications and materials were made available on this website.

Additionally, the Authority participated in public meetings hosted by other agencies to provide project information and obtain feedback. The places and dates of these meetings are listed in Table 9-5.

9.4.4 Tribal Coordination Meetings

Under NEPA Assignment, the Authority is required to fulfill the requirements of Section 106 (36 C.F.R. Part 800) pursuant to the National Historic Preservation Act (NHPA) (see Section 9.4.6) Section 106 Programmatic Agreement and the NEPA Assignment MOU. Refer to Section 3.17 Cultural Resources, for a detailed discussion of NEPA Assignment. The FRA is responsible for conducting government-to-government consultation with federally recognized Native American



tribes. This includes preparing a memorandum of agreement for each project section that adversely affects, or has the potential to adversely affect, historic properties and participating in the resolution of disputes. The FRA delegated responsibility to the Authority for implementation of the following provisions of the agreement: consult with non-federally recognized Native American groups, other consulting parties, and the public; conduct Section 106 reviews; and coordinate with Native American groups and other interested parties to participate in each undertaking MOU. For a full list of responsibilities, refer to the Section 106 PA (Authority et al. 2011).⁷

As part of the cultural resource investigation efforts conducted under Section 106, FRA and the Authority consulted with federally recognized Native American tribes. Tribal input is sought early in the project planning process to obtain their input on concerns for tribal heritage resources potentially affected by the project. Concerns were accounted for early in project planning. Outreach and consultation with tribal stakeholders occurred and will continue to occur at key milestones throughout the project delivery process.

FRA initiated project-level government-to-government outreach in 2009 and 2010 for the Palmdale to Los Angeles Project Section. The NAHC provided the Authority with a list of Native American tribes and representatives on September 10, 2009; October 26, 2011; February 9, 2014; and March 3, 2014. In July 2014, the Palmdale to Burbank Project Section was established. The NAHC provided the Authority with a list of Native American tribes and representatives on August 11, 2014; February 9, 2015; and July 16, 2018. The following tribes and tribal representatives identified for the Palmdale to Burbank Project Section were contacted to provide them with information and updates about the project section and to seek tribal input regarding concerns about effects on important tribal cultural resources:

Pursuant to the NEPA Assignment MOU between FRA and the State of California executed on July 23, 2019, the Authority has assumed the FRA's responsibilities for complying with the requirements of Section 106. However, under the NEPA Assignment MOU, the FRA retains the responsibility to conduct formal government-to-government consultations.



Of the 25 tribes invited, thirteen representatives of the following six tribes attended the meetings:

- Gabrieleño/Tongva Nation
- Tongva Ancestral Territorial Tribal Nation
- Randy Guzman Folkes (Chumash/Tataviam)
- Fernandeño Tataviam Band of Mission Indians
- Yuhaaviatam of San Manuel Nation (formerly San Manuel Band of Mission Indians)
- Gabrieleño Band of Mission Indians Kizh Nation

Tribal representatives from the Gabrieleño Band of Mission Indians Kizh Nation and the Fernandeño Tataviam Band of Mission Indians have not only consulted with the Authority, but also have participated in the archaeological surveys completed on Bureau of Land Management and ANF lands for the Palmdale to Burbank Project Section. Representatives from all four of the tribal consulting parties will continue to participate in all surveys once access is granted. Tribal representatives from the consulting parties will also monitor activities during construction in archaeologically sensitive areas associated with the Palmdale to Burbank Project Section.

In January 2017, the Authority hosted a chartered bus tour of the Palmdale to Burbank Project Section specifically for the consulting party tribes. The intent of the tour was to provide the tribal stakeholders an opportunity to view the landscape in which the Build Alternatives are proposed and to learn more about the proposed engineering features for each of the Build Alternatives. Map-books of the alignments were provided to help orient the participants during the tour, and stops were made at key locations along each of the routes. The tour included 27 participants, including representatives from each of the consulting tribes, representatives from FRA, the Authority, the Regional Consultant team, and archaeologists with the USFS. Following the alignment tour, the Authority and FRA held follow-up focused meetings with each of the consulting tribes in March 2017 to seek further input regarding cultural resource concerns along the alignments and to collaborate on strategies to avoid and minimize effects on tribal cultural resources. Consultation with tribal stakeholders regarding the Palmdale to Burbank Project Section is ongoing and iterative.

The Authority and FRA are engaged in ongoing meetings with the tribal consulting parties. As consulting parties, the tribes are afforded a chance to review and contribute to cultural resources technical reports; participate in tribal monitoring opportunities (including monitoring required during pedestrian archaeological field surveys and ground disturbing construction activities in culturally sensitive areas); and contribute to the development of treatment and mitigation for impacts on significant resources. Meetings with tribal representatives are included in Table 9-5. A more detailed discussion of tribal outreach and consultation efforts, and the findings of the cultural resources investigation for this project section, is provided in Section 3.17, Cultural Resources.

9.4.5 Agency Meetings and Consultation

The Authority and FRA consulted with cooperating or participating federal, state, and local agencies under NEPA and with trustee and responsible agencies under CEQA regarding specific resource issues. Interested state, federal, and local agencies were also consulted throughout the project development process. The Authority and FRA have met with federal agencies numerous times. Local agencies hosted and facilitated meetings with the public, organizations, and members of the press. The agencies that the Authority and FRA met with include the following:

Responsible agencies under CEQA are defined in Public Resources Code 21069 as "any public agency, other than the lead agency, which has responsibility for carrying out or approving a project." Chapter 2, Alternatives provide a list of responsible agencies and permitting procedures. Table 9-5 provides a full list of the various agency meetings.

9.4.6 National Historic Preservation Act (NHPA)

The Authority and FRA executed the NHPA Section 106 PA in June 2011 (Authority 2011b). The Section 106 PA provides an overall framework for conducting the Section 106 process for this project section and includes interested party and tribal consultations. In compliance with the NHPA, the Authority and FRA invited consulting parties (including other federal, state, regional, or local agencies that may have responsibilities for historic properties) to review project historic resource reports and findings.

In accordance with Stipulation V.A of the Section 106 PA, outreach and consultation with potentially interested parties, including the general public; historic preservation interest groups or individuals; and other federal, state, regional, or local agencies regarding effects on historic properties entirely in Los Angeles County. Eight responses from interested parties were received, including the California SHPO, which designated the FRA as lead federal agency for Section 106 on September 2, 2015. While the Advisory Council on Historic Preservation is the overseeing agency for Section 106, the Advisory Council on Historic Preservation did not need to be involved in the consultation and outreach process. For additional historic preservation interest groups or individuals contacted, see Table 3.17-3, in Section 3.17, Cultural Resources.

9.4.7 Section 404 Process, Clean Water Act

In December 2010, the Authority, FRA, USEPA, and the USACE signed a Tier 2 MOU to facilitate coordination between the environmental review process under NEPA and the regulatory authorization processes of Section 404 of the Clean Water Act and Section 14 of the Rivers and Harbors Act (33 U.S.C. 408). The MOU establishes a process under which the four agencies reach agreement on three milestones for each project section. These three milestones are as follows:

- Checkpoint A: Purpose and Need—In December 2014, the Authority and FRA submitted a
 Purpose and Need Statement to the USACE and USEPA pursuant to the MOU's
 Checkpoint A provisions. Both agencies provided written concurrence with the Purpose and
 Need Statement (respectively, on December 18 and 29, 2014).
- Checkpoint B: Range of Alternatives —The MOU establishes that Checkpoint B consider additional information developed subsequent to programmatic analyses of alternatives. This information is used to inform the selection of a reasonable range of alternatives for consideration in the Tier 2 environmental review. The Checkpoint B Summary Report was sent to the USACE and the USEPA in December 2020. Pursuant to the MOU, the Checkpoint B Summary Report identified the range of alternatives to be carried forward in the Draft



EIR/EIS. USEPA and USACE concurred with the selection of these alternatives on December 16, 2020, and December 17, 2020, respectively (USACE 2020 and USEPA 2020).

- Checkpoint C: Determination of the Least Environmentally Damaging Practicable Alternative (LEDPA)—The Authority prepared and submitted a Checkpoint C Summary Report to USACE and USEPA for review in July 2023. This third and final submittal consists of the assembly and assessment of information contained in this Final EIR/EIS and associated technical reports for consideration by USACE and USEPA to determine the preliminary LEDPA and provide a formal agency response. The documentation includes those analyses completed to meet requirements of NEPA, Sections 401 and 404 of the Clean Water Act, Section 14 of the Rivers and Harbor Act, and includes consideration of compliance with the federal Endangered Species Act and the National Historic Preservation Act.
- Section 7 Consultation, Federal Endangered Species Act— USACE and USEPA concurred with the selection of the SR14A Build Alternative as the LEDPA on January 5, 2024, and January 9, 2024, respectively (USACE 2024 and USEPA 2024).

When a federal agency takes a discretionary action, it must comply with Section 7(a)(2) of the Federal Endangered Species Act, which describes two duties for a federal action agency: (1) an independent, substantive duty to ensure its proposed actions are not likely to jeopardize the continued existence of an endangered species, and (2) an independent, substantive duty to ensure its proposed actions would not result in the destruction or adverse modification of critical habitat. To meet these duties, the federal action agency must use the best available scientific and commercial data to assess the effects of the proposed action, and it must consult with the USFWS and/or NMFS for assistance. Through formal and/or informal Section 7 consultations, federal agencies determine whether a proposed action is likely to jeopardize the continued existence of a listed species and/or result in the destruction or adverse modification of its critical habitat.

On March 1, 2011, FRA designated the Authority as the nonfederal representative for Section 7 consultation for the HSR program.⁸ A Biological Assessment was prepared for the Palmdale to Burbank Project Section to initiate formal consultation with USFWS and satisfy all information requirements identified at 50 C.F.R. Part 402.14(c) (Authority 2021). Consultation with the NMFS was not initiated because no species or designated or proposed critical habitat under that agency's jurisdiction occurs or has potential to occur in the Palmdale to Burbank Project Section.

The Authority informally consulted with the USFWS throughout development of the Biological Assessment and associated technical studies and preparation of the Draft EIR/EIS. Meetings began in 2015 to discuss the Section 7 consultation approach and project overview, and to determine whether the project may affect listed species or critical habitat. Meetings were also held to discuss conservation strategies and the species modeling approach by which impacts on species could be identified and avoided. Discussions included approaches to documenting concurrences during the consultation process for specific species modeling, informal review of species natural history information (e.g., listing status, species description, life history attributes, and conservation needs), and No Effect determinations. Preview and discussion of species models, conservation targets, No Effect determinations, and Section 7 schedule and timeline continued regularly.

⁸ A federal agency can designate a nonfederal representative (a person, agency, or organization) to conduct informal consultation or prepare a Biological Assessment. The nonfederal representative is designated by written notice to the director. If a permit or license applicant is involved and that entity is not the designated nonfederal representative, then the applicant and the federal agency must agree on the choice of the designated nonfederal representative (50 C.F.R. Parts and 402.08). Pursuant to the NEPA Assignment MOU, the Authority has assumed the federal responsibility to conduct formal consultation.

⁹ No Effect determinations were made for federally listed, proposed, and candidate species that would not be affected by the proposed project due to a lack of suitable habitat, local or regional extirpations, and/or because the project falls outside the species' known and extant geographic range.



Starting in 2016, preliminary species effects assessments (i.e., examination of potential adverse effects of the proposed project on listed species) were presented to the USFWS for review and feedback prior to incorporation into the Biological Assessment. In April 2023, the Authority submitted a Draft Biological Assessment to USFWS and is currently conducting formal consultation with the USFWS under Section 7.

9.4.8 U.S. Forest Service Coordination

The USFS is a Cooperating Agency involved in the NEPA review process, agreed by letter dated August 25, 2014. The Authority informally consulted with USFS throughout the preparation of the Draft EIR/EIS and associated technical reports. Meetings began in 2014 to discuss various topics.

From July to December of 2015, the Authority presented project descriptions, maps of the regional study area, general alignments with 500-foot buffers, the selection of a preferred Build Alternative, draft species list, and draft species modeling approach. The Authority continued coordination with the USFS regarding species information, effects determinations, development of modeling tools and data exchange and agency concurrence decisions.

Additional coordination with the USFS occurred in 2016, which included continued species information and mitigation coordination, among interagency coordination. Starting in 2016, preliminary species effects assessments (i.e., examination of potential adverse effects of the proposed project on listed species) were presented to the USFS for feedback on mitigation lands acquisition. For information regarding the consultation history of natural resource agencies see Table 3.7-3, in Section 3.7, Biological and Aquatic Resources.

In 2017, the Authority presented the methodology for assessing impacts on USFS lands to the USFS and responded to the agency's comments. Further consultation with the USFS was ongoing between 2017 and publication of the Draft EIR/EIS. In March 2019, the Authority held a meeting with the USFS to discuss impacts of tunneling on hydrological conditions. USFS expressed a desire to work with the Authority on developing a menu of possible mitigation measures to address foreseeable impacts and establishing baseline conditions for monitoring potential changes in hydrogeologic conditions. During 2021, four additional meetings occurred with the USFS specifically for the topics regarding effects of tunnel construction on hydrologic and biological resources. In April of 2021, two meetings were held to discuss the USFS cooperating agency comments that were provided to the Authority for Section 3.7, Biological and Aquatic Resources, and Section 3.8, Hydrology and Water Resources.

9.5 Notification and Circulation of the Draft EIR/EIS

In September 2022, public notice regarding the availability and circulation of the Draft EIR/EIS was provided pursuant to NEPA and CEQA requirements, and text of the public notice was prepared in English, Spanish, Armenian, and Arabic. Notification included publication of an advertisement in newspapers with general circulation in areas potentially affected by the project. The Draft EIR/EIS public comment period was advertised in the following newspapers:

The newspaper advertisements indicated that the Draft EIR/EIS was available on the Authority's website for review. These advertisements and the Authority's website also noted the times and locations of workshops, public hearing, and the period during which public comments would be received. A summary, fact sheet, and Notice of Availability were provided in English, Spanish, Armenian, and Arabic; these items were distributed by direct mail to members of the public who subscribed to the project mailing list, had attended project events (scoping, public meetings, etc.), or had sent comments or questions via email or on the Authority's website. In addition, notice was sent to persons who own or live on properties as follows: 10

- Within 1,000 feet of the Build Alternatives' footprints for above ground activity
- Within 500 feet of the Build Alternatives' footprints for tunnel activity
- Within 1,000 feet of the Build Alternatives' footprints for unincorporated areas
- Within 500 feet of the Build Alternatives' footprints for incorporated areas
- Within 1,200 feet of the Burbank Airport Station footprint

A postcard in English, Spanish, and other languages was mailed to additional stakeholders who had indicated interest in the project and requested that they be kept informed. A Notice of Completion indicating the availability of the Draft EIR/EIS was filed with the State Clearinghouse, and copies were sent to state agencies. Several dozen notices were displayed at businesses, public gathering places (e.g., post offices, Amtrak stations, local libraries, community centers), and the offices of city and county elected officials in the communities surrounding the project section alternative alignments.

Printed and/or electronic copies of the Draft EIR/EIS were sent to federal, state, and local agencies; regional transportation agencies; and other organizations and persons who had expressed an interest in the project. Transportation agencies with facilities within 0.5 mile of the alignment and regional transportation agencies included the Antelope Valley Transit Authority, the Burbank Transportation Division, Santa Clarita Transit, Metrolink, the Los Angeles Public Works Department, Amtrak, and Mission City Transit. The entire Draft EIR/EIS, and appendices are available on the Authority's website (www.hsr.ca.gov). Electronic copies of these documents are available on request at no cost at the Authority's main office (700 L Street, Suite 800, Sacramento, California 95814) and Southern California regional office (355 S. Grand Avenue, Suite 2050, Los Angeles, California 90071). Electronic copies also can be requested by mail or at: https://buildhsr.com/contact_us/. Printed and electronic copies of the Draft EIR/EIS were available at public libraries, the Authority's offices, and county clerk offices. Chapter 10, EIR/EIS Distribution, provides a full distribution list for the Draft EIR/EIS with updates for this Final EIR/EIS.

California Governor Gavin Newsom announced directives to address the need to slow the spread of novel coronavirus (COVID-19) in California (and globally) by prohibiting gatherings of any size. In addition, Governor Newsom issued Executive Order N-33-20, which ordered all individuals living in the state of California to stay home or at their place of residence until further notice. To comply with the governor's directives and Executive Order N-33-20, and to protect public health, the traditional in-person format of the public hearing was changed to a "virtual" public hearing held online and via telephone.

¹⁰ The boundaries of each of the Build Alternative footprints for unincorporated areas and incorporated areas differ in distance due to the variance in both population rates and parcel ownership. In unincorporated areas, parcels tend to be larger; therefore, a larger footprint is necessary.



9.6 Publication and Review of the Draft EIR/EIS

The Palmdale to Burbank Project Section Draft EIR/EIS was posted on the Authority's website for public review on September 2, 2022, and was formally made available to California state agencies by the State Clearinghouse beginning August 31, 2022. The public comment period ran from September 2, 2022, to November 1, 2022, initially; but was extended to December 1, 2022, for a total of 90 days. A news release was posted on the Authority's website on September 7, 2022, and posted in regional and major newspapers on September 1, 2022. A news release dated September 27, 2022, was posted on the Authority's website, which notified the public that the comment period had been extended.

To provide the greatest opportunity for agencies and the public to review and comment on the Palmdale to Burbank Project Section Draft EIR/EIS, the Authority provided widespread notice of its availability.

9.6.1 Public and Agency Information Meetings and Hearings

To present the Palmdale to Burbank Project Section Draft EIR/EIS and give the public an opportunity to ask questions and collect information about the project, the Authority held a virtual open house meeting (October 6, 2022) and online public hearing (October 18, 2022) during the public circulation and comment period. The online meeting and online public hearing were conducted in English and Spanish, with simultaneous translation offered. Interpretation of other languages was available on request, but no requests were received.

The online open house was held on October 6, 2022, from 5:00 p.m. to 7:30 p.m. This meeting was held via Zoom webinar and included an English presentation and question-and-answer session, followed by a Spanish presentation and question-and-answer session. This meeting provided an overview of the environmental document and opportunities for attendees to ask questions about the Draft EIR/EIS. Information on where to access the environmental document and how to participate in the public comment process was also provided.

The meeting moderator facilitated the question-and-answer session by alternating the selection of written questions and comments submitted by attendees via the Zoom "Chat" and "Raised Hand" features to allow participants the option to either write or voice their question or comment. The moderator read questions submitted via "Chat" out loud, and then assigned them to a specific panelist to address. During this session, participants were informed that official public comments would not be accepted at this meeting, but that comment could be submitted during the public hearing on October 18, 2022.

The online public hearing was held on October 18, 2022, from 3:00 p.m. to 8:00 p.m. The public hearing was conducted as a Zoom webinar over a 5-hour period in English, with Spanish interpretation. The online public hearing included a PowerPoint presentation that featured instructions, commenting rules, and information. The presentation also contained information on how attendees could communicate with the project team, and outlined the public comment period. A total of 76 attendees participated in the Zoom webinar, providing both written and verbal comments. Approximately 11 attendees identified as stakeholders (including representatives of state and local governments, a transportation agency, community action groups, and a neighborhood council) were in attendance.

Instructional announcements were made at the top of each hour and comments were allowed for 50 minutes, with a 10-minute break at the end of each hour. Prompts in English and Spanish were provided via Zoom "Chat" to reinforce information presented on slides, and remind attendees of how and where to comment, access information on the Draft EIR/EIS, and ways to communicate with the Authority. The final request for comments came at 7:50 p.m., and the online public hearing adjourned as scheduled at 8:00 p.m.

9.6.2 Comments on the Draft EIR/EIS

The public was given the opportunity to comment in several ways. Comments could be submitted to the Authority via postal mail, verbally at the virtual public hearing, through the project telephone



hotline, or via email. During the comment period, there were 481 comment letters and 2,489 total comments submitted on the Palmdale to Burbank Project Section Draft EIR/EIS. After the close of the public comment period, the Authority received 26 submissions that were included in the record.

The Authority received comment submissions from 10 federal agencies, 10 state agencies, 4 elected officials, 41 local agencies, 64 businesses and organizations, and 351 individuals. Eighteen comment submissions were received during the October 18, 2022, online public hearing. Key comments addressed the following topics:

- Tunneling—Comments expressed concern about impacts from tunneling, including hydrology, noise, and vibration.
- Funding—Comments expressed concern regarding project costs, funding availability for construction and operation, and prudent use of public funding.
- Landscape—Comments expressed concerns about impacts on the natural landscape surrounding the foothill communities, including Kagel Canyon, Lake View Terrace, Shadow Hills, and Sunland-Tujunga.
- Construction—Comments expressed concerns related to construction effects on surrounding neighborhoods.
- Property acquisition—Comments expressed concerns about the right-of-way acquisition
 process and relocation assistance to be provided by the Authority, as well as impacts on
 property values.

The Authority assessed and considered all substantive comments on the Draft EIR/EIS that were received by the close of the comment period, and included a response, when necessary, in the Final EIR/EIS. Responses to comments received from September 2, 2022, through December 1, 2022, are available in Volume 4 of this Final EIR/EIS.

9.6.3 Response to Common Comments

This section explains the method used for responding to comments, as well as the organization of the responses to comments on the Palmdale to Burbank Project Section Final EIR/EIS. Written responses to public comments received between September 2, 2022, and December 1, 2022, are provided in Volume 4 of this Final EIR/EIS. Comments received after December 1, 2022 and written responses are also provided in Volume 4.

The Authority reviewed the comment transmittals and their attachments, identifying individual issues to which the comments pertained. After identifying the individual comments in the cards, letters, verbal transcripts, and emails, the Authority grouped individual comments by resource issue and assigned each set of comments to technical experts in the appropriate disciplines to prepare a response. After reading through their assigned comments, the technical experts grouped the individual comments by resource topic and prepared draft responses. Before completion of the Final EIR/EIS, senior-level experts then reviewed each response to ensure technical and scientific accuracy, clarity, and consistency, and that the response addressed the comment. Responses to individual comments from federal agencies are provided in Chapter 19, state agencies in Chapter 20, elected officials in Chapter 21, local agencies in Chapter 22, business organizations in Chapter 23, and individuals in Chapter 24. The text or transcript of each comment is provided with the response arranged below it. In some cases, the response will refer the reader to a standard response, as described below.

As an example of a comment and its response, the Office of City of Los Angeles Councilmember Monica Rodriguez was assigned Comment Submission Number 4142 and Comment Number 9107. The text of the comment with the Authority's corresponding response is found in Chapter 21, Response to Comments from Elected Officials.

When multiple commenters submitted essentially the same comment, the Final EIR/EIS grouped those comments and provided a single master response. Chapter 17 of Volume 4 provides a summary of the comment themes and the master responses, as well as a list of the comment numbers that the responses are intended to address. When reading the comments submitted, a



reference to find the master response is provided. In other cases, a custom response is provided in the comment submittals. The master responses shown in Chapter 17 of Volume 4 are organized first by general themes and then by EIR/EIS section (Purpose and Need, alternatives, environmental resource, etc.).

Where appropriate and consistent with CEQA and NEPA, the Final EIR/EIS responds to the substantive and significant environmental issues that have been raised by commenters without necessarily responding to each individual comment. As required under CEQA and NEPA, the comments received are included, and the commenters identified in Volume 4 of this Final EIR/EIS.

California Public Resources Code Section 21091(d)(1) and (d)(2) provides the basis for this approach under CEQA:

- (d) (1) The lead agency shall consider comments it receives on a draft environmental impact report, proposed negative declaration, or proposed mitigated negative declaration if those comments are received within the public review period.
- (2) (A) With respect to the consideration of comments received on a draft environmental impact report, the lead agency shall evaluate comments on environmental issues that are received from persons who have reviewed the draft and shall prepare a written response pursuant to subparagraph (B). The lead agency may also respond to comments that are received after the close of the public review period.
- (B) The written response shall describe the disposition of each significant environmental issue that is raised by commenters. The responses shall be prepared consistent with California Code of Regulations, Title 14, Section 15088.

Section 14(s) of the FRA's Procedures for Considering Environmental Impacts (64 Fed. Reg. 28545) validates this approach under NEPA.

(s) In a final EIS, a compilation of all responsible comments received on the draft EIS, whether made in writing or at a public hearing, and responses to each comment. Comments may be collected and summarized except for comments by Federal agencies and where otherwise required by Federal law or regulation. Every effort should be made to resolve significant issues before the EIS is put into final form. The final EIS should reflect such issues, consultation, and efforts to resolve such issues, including an explanation of why any remaining issues have not been resolved.

9.6.4 Engineering and Design Refinements after Publication of the Draft EIR/EIS

Since the close of the public comment period for the Draft EIR/EIS on December 1, 2022, the Authority has reviewed the public comments received and continued to consult with local jurisdictions and property owners to identify opportunities to address concerns, and reduce or avoid impacts where possible. The Authority has also continued to work closely with regulatory agencies with jurisdiction over some components of the project.

Design refinement highlights include the vicinity of Bee Canyon where the Authority minimized the temporary and permanent footprint for the Refined SR14 and SR14A Build Alternatives. The temporary footprint for both Build Alternatives was reduced to 0 acres between Agua Dulce Canyon Road and Soledad Canyon Road. The permanent footprint along this area prior to the Bee Canyon design refinement was 132.74 acres (Refined SR14 Build Alternative) and 129.41 acres (SR14A Build Alternative). The Bee Canyon design refinement reduced the permanent footprint to 105.78 acres and 100.87 acres, respectively, for a reduction of 26.96 acres for the Refined SR14 Build Alternative and 28.54 acres for the SR14A Build Alternative. Additionally, with respect to Portal 9, the Authority reduced the temporary cut width through the Lang Mine area, where the Nike Missile facility (LA-98) used to be and where contaminated materials are expected to be found. The width at the cut-bottom elevation has been reduced from 455 feet to 200 feet. This refinement results in an overall reduction of total spoils at Portal 9 by 2.66 million cubic yards (both hazardous and non-hazardous).



Volume 3 Preliminary Engineering for Project Definition (PEPD) of this Final EIR/EIS memorializes minor changes to alignment plans and to correct errors in response to public comments. An updated HSR viaduct headway and updated bridge section were added to PEPD Record Set REV02 Track Alignment Plans. An access road to the Boulder Mobile Home water tank was added to PEPD Record Set Addendum SR14A / E1A / E2A Roadway and Grade Separation Plans and PEPD Record Set Addendum SR14A / E1A / E2A Grading and Drainage Plans. An updated structure type to steel truss and the location of this structure referred to the stationing of the Tujunga Channel based on the USACE Upper Los Angeles and Tujunga Wash HEC-RAS Models were added to PEPD Record Set REV02 Bridges and Elevated Structures Plans. Utility labels and tables were added, and utility owners and utility identifications were corrected in the PEPD Record Set Addendum SR14A / E1A / E2A Utility Relocation Plans; utility owners and identifications were updated in PEPD Record Set REV02 Utility Relocation Plans Volume I of II. Utility owners were corrected in PEPD Record Set REV02 Utility Relocation Plans Volume II of II.

PEPD Plan Sets incorporated the design refinement of Build Alternatives Refined SR14 and SR14A project footprint in the Bee Canyon and Pacoima areas. The access road, overhead powerline and water line to tunnel portal 4/4A in Bee Canon were moved adjacent to the HSR alignment and the temporary construction staging and layout areas were revised to stay within the permanent environmental footprint. The construction staging and layout areas associated with the tunnel adits in Pacoima were revised to reduce the project environmental footprint and limit the impact on Jurisdictional Waters.

These changes were reflected in the Track Alignment Plans, Roadway and Grade Separation Plans, Grading and Drainage Plans, Utility Relocations Plans, Construction Staging Plans, and Tunnel Plans of the PEPD Record Set REV02 and PEPD Record Set Addendum SR14A/E1A/E2A.

9.7 Log of Public and Agency Meetings

Table 9-5 lists outreach and related meetings for the Palmdale to Burbank Project Section. These meetings generally took place after publication of the NOI and NOP in the summer of 2014. However, initial Section 106 tribal consultation meetings and meetings leading up to the decision to divide the Palmdale to Los Angeles Project Section are also listed in Table 9-5. A variety of meeting types and outreach activities were conducted. Federal, state, regional, and local agencies, tribes, elected officials, neighborhood councils, organizations, businesses, and the general public participated in these meetings to obtain project information and provide feedback. Additional public and agency meetings have occurred between 2017 and 2021. Due to the COVID-19 pandemic, meetings in 2020 through October 2021 were held virtually over Zoom meetings.
