



NOTICE OF PROPOSED AWARD

**Right of Way Engineering and Survey Support Services (Merced to Bakersfield ROWE I)
Request for Qualifications No. HSR24-60
August 20, 2025**

This Notice of Proposed Award identifies the top-ranking (most highly qualified) Offeror¹ approved by the California High-Speed Rail Authority's (Authority) Chief Executive Officer (CEO) for award of the Agreement.

On or before July 8, 2025, the Authority received five Statements of Qualifications (SOQ) in response to its Request for Qualifications (RFQ) for Right of Way Engineering and Survey Support Services (Merced to Bakersfield ROWE I) issued on April 28, 2025. An SOQ was submitted by the following Offerors:

- (5) Westwood Professional Services (formerly O'Dell Engineering), which includes team members Bennett Engineering Services (DBE, SB), Conaway Geomatics (DVBE), Diversified Project Services International, Inc. (SB), ESP Surveying, Inc. (DBE, MB), and Figueroa Surveying, Inc. (DBE, SB)

The Offerors were evaluated and scored on their SOQs and Discussions pursuant to the criteria set forth in the RFQ. The Offeror's rankings are shown below.
