



Multiple Award Task Order Contract (MATOC)



What is a MATOC?

A Multiple Award Task Order Contract (MATOC) is a type of contract that allows the California High-Speed Rail Authority (Authority) to award multiple contractors an indefinite-delivery, indefinite-quantity (IDIQ) contract. The Authority requests proposals from qualified entities and issues work on a task order basis.

This approach is ideal for large-scale programs, offering a flexible, efficient, and competitive method to procure a wide range of construction services.

MATOC Benefits

Streamlined Procurement: Eliminates the need for separate contracts for each project, saving time and reducing costs for both the Authority and contractors.

Faster Project Start: Work can begin after the task order process is complete, versus the monthslong process to procure individual contracts.

Built-in Flexibility: Supports varying project scopes and timelines.

Small Business Opportunities: Enables small businesses to act as prime contractors and expand their portfolios. Task orders range from a few thousand dollars up to \$15 million, allowing firms to scale their participation across multiple projects.



Request for Proposals for Repair and Construction Projects

The Authority issued a Request for Proposals (RFP) to support a wide range of repair and minor construction projects on real property across the Central Valley including Merced, Madera, Fresno, Tulare, Kings, and Kern counties. The Authority intends to award a MATOC to three pools of businesses:

- **Large business** contractors for the entire California High-Speed Rail project geographic region.
- **Small business** contractors in Merced, Madera, Fresno, Tulare, Kings, and Kern counties.
- **Authorized utility** relocation contractors.

Work will be defined in individual task orders and will include:



Construction, construction with design elements, and construction with land surveying.



Geotechnical investigations, alterations, improvements, and repairs.



Utilities, utility investigations utilizing new technology, communication utilities, and site-work.



Specialty trade services, masonry, roofing, heating, cooling, and air conditioning, concrete, etc.



Material hauling, tree removal, weed removal, and other construction-related services.
