

CP 1 Progress Update Forecast vs. Actual - Guideway






CP1 – Forecasted vs. Actual Progress Update

- Structures one structure delayed and will be complete by end of summer 2019
 - Avenue 8 Overpass
 - Finalizing construction and maintenance agreement with Madera County
 - Expected resolution by the end of the summer
- Guideway progressing as forecasted




CP 1 Progress to Completion – Plan vs. Actual






CP 1 Progress Update ROW Acquisition Status

• 10 new parcels were identified primarily for utility relocations and railroads






CP 1 Environmental Clearance – ITP Amendments






CP 1 Planned vs. Actual Expenditures – Near Term

- Expenditures lower than forecasted due to required redesigns of third party assets and utility relocations.
 - Mitigation: Targeting critical design areas and utility relocations to maximize clearance of guideway and structures


CP 1 Critical Actions – Getting to Construction


- Third Party Resetting relationships
 - CDFW
 - Intrusion Protection Barrier (IPB) Re-Exam
 - Hairy Orcutt Grass Occupied Pools signed and executed agreement to commence construction prior to mitigation
 - PG&E Finalizing design and access issues & complete 6-month shelf reviews
 - Irrigation Districts
 - Finalize construction and postconstruction requirements
 - AT&T: Stagger cut-over and DB designed workarounds
 - UPRR Design Variances: Focus Team targeting to resolve quickly


- Commercial
 - Time Impact Analysis (TIA) to Improve baseline schedule
 - Intrusion Protection Barrier (IPB) System
 - Negotiation underway:
 - Mechanically Stabilized Earth (MSE) Walls
 - Northern Extension
 - Herndon Avenue
- Design Engaging Team members to:
 - Resolve utility design and Rail Road variances
 - Finalize designs in cooperation with third-party requirements
- Utility Provisional Sums: Complete design & start construction
- ROW working with DB to identify and acquire DB requested additional ROW for utility relocations






CP2-3 – Forecasted vs. Actual Progress Update

- Structures completion behind forecast
 - Utility relocations PG&E utility relocations at South, Peach and 9th Avenues progressing, work expected to commence July 2019
 - Design 16 structures behind forecast due to geotechnical issues requiring additional design review
 - Doubling weekly review and comment resolution meetings and expect resolution of design issues in the fall
- Guideway completion behind forecast
 - 4 miles of guideway cleared, but not started
 - Identified need for greater analysis of soft soil conditions
 - 3D model development and analysis is underway and expected to be complete by end of summer
 - Environmental Clearance working with CDFW on outstanding wildlife permeability measures
 - Agreement with CDFW in August for Kings River Complex, Cross Creek/Deer Cree and ITP Amendments expected to be issued over next few months to clear guideway in these areas
 - ROW Cairo Avenue and Kings River Complex negotiations made great progress
 - Changes in design and newly identified utilities lead to additional pre-acquisition activities




CP 2-3 Progress to Completion – Plan vs. Actual






CP 2-3 Expenditures Near-term – Planned v. Actual






CP 2-3 Progress Update ROW Acquisition Status






CP 2-3 Environmental Clearance – ITP Amendments


CP 2-3 Critical Actions – Getting to Construction

- Third Party Resetting Relationships
 - Fresno County permit CP Team leader and Regional Director meeting with Fresno County Director monthly to work through issues
 - Kings County
 - Irrigation Districts execute agreements & approval of CDFW sub-notifications
 - Sempra optimize design and construction schedules and finalize out grants for Sempra relocated utilities
 - PG&E reset design and access expectations, move approved packages to construction
 - CDFW
 - Multiple Incidental Take Permit (ITP) amendments being proposed to CDFW to align with Design Builder's concepts
 - Trapping season has begun for San Joaquin Antelope squirrel
 - BNSF agreements to be Executed

- Commercial Project Change Orders
 - Time Impact Analysis (TIA)
 - Intrusion Protection Barrier (IPB) System
 - Mechanically Stabilized Earth (MSE) Walls
 - Deer Creek and Cross Creek Bridges
- Design Form Focus Team to drive completing design in line with ROW and Environmental
- Utility Provisional Sums: Complete design & start construction
- ROW Focus Team targeting DB-identified critical parcels
 - Delivery dates linked to schedule meets or exceeds forecasted delivery date on majority of acquisitions




CP 4 Progress Update Forecast vs. Actual - Structures




CP4 – Forecasted vs. Actual Progress Update

- Structures one structure cleared, not yet started
 - Poso Creek bridge is cleared, not yet started
 - Construction delayed due to environmental requirements for nesting birds
 - Environmental clearance ITP amendment for SR46 expected to be issued in August, clearing the structure for construction
 - Design completed on all structures by June except Merced and Poso Avenues
 - Merced Avenue design is at 90% design level
 - Poso Avenue DB is addressing comments from Wasco
- Guideway progressing as forecasted
 - Environmental clearance
 - Resolving CDFW wildlife permeability measures for Wasco-at-grade
 - Additional burrow excavation required to ensure trapping of endangered species
 - Construction delayed due to environmental requirements for nesting birds
 - Design negotiation with Semitropic Irrigation District expected to be resolved in August, furthering design




CP 4 Progress to Completion – Plan vs. Actual






CP4 Fiscal Year - Planned vs. Actual Expenditures






CP 4 Environmental Clearance – ITP Amendments





- Third party relationships Resolve design and access issues with key third party utility owners
 - PG&E
 - Sempra
 - Semitropic
 - Kern County
 - CDFW Multiple Incidental Take Permit (ITP) amendments being proposed to CDFW to align with DB design
- Commercial Project Change Orders
 - Semitropic additional facilities
 - Intrusion Protection Barrier (IPB) System
 - Mechanically Stabilized Earth (MSE) Walls
- Design Forming joint Focus Team for design review
 - Wasco Viaduct
 - DB QA/QC program and process

- Utility Provisional Sums: Complete design & start construction
- ROW DB Critical ROW Remaining
 - 23 parcels remain
