


Figure 3.14-C-1 Project Segments




Figure 3.14-C-2 Important Farmland and Grazing Land





Figure 3.14-C-2 Important Farmland and Grazing Land (Sheet 3 of 12)




Figure 3.14-C-2 Important Farmland and Grazing Land (Sheet 5 of 12)




Figure 3.14-C-2 Important Farmland and Grazing Land





Figure 3.14-C-2 Important Farmland and Grazing Land (Sheet 7 of 12)




Figure 3.14-C-2 Important Farmland and Grazing Land (Sheet 9 of 12)




Figure 3.14-C-2 Important Farmland and Grazing Land (Sheet 12 of 12)












Figure 3.14-C-3 Crop Cover (Sheet 5 of 12)







Figure 3.14-C-3 Crop Cover (Sheet 6 of 12)





Figure 3.14-C-3 Crop Cover (Sheet 8 of 12)




Figure 3.14-C-4 Williamson Act Contract Land





Figure 3.14-C-4 Williamson Act Contract Land (Sheet 3 of 12)




Figure 3.14-C-4 Williamson Act Contract Land





Figure 3.14-C-4 Williamson Act Contract Land (Sheet 9 of 12)




Figure 3.14-C-4 Williamson Act Contract Land (Sheet 11 of 12)




Figure 3.14-C-5 Land Zoned for Agriculture




Figure 3.14-C-5 Land Zoned for Agriculture (Sheet 3 of 12)




Figure 3.14-C-5 Land Zoned for Agriculture (Sheet 4 of 12)




Figure 3.14-C-5 Land Zoned for Agriculture (Sheet 5 of 12)






Figure 3.14-C-5 Land Zoned for Agriculture (Sheet 6 of 12)






Figure 3.14-C-5 Land Zoned for Agriculture (Sheet 7 of 12)








Figure 3.14-C-5 Land Zoned for Agriculture (Sheet 8 of 12)






Figure 3.14-C-5 Land Zoned for Agriculture (Sheet 9 of 12)




Figure 3.14-C-5 Land Zoned for Agriculture (Sheet 12 of 12)






Figure 3.14-C-6 Alternative 1 Impacts to Important Farmland and Grazing Land (Sheet 1 of 12)




Figure 3.14-C-6 Alternative 1 Impacts to Important Farmland and Grazing Land






Figure 3.14-C-6 Alternative 1 Impacts to Important Farmland and Grazing Land (Sheet 3 of 12)





Figure 3.14-C-6 Alternative 1 Impacts to Important Farmland and Grazing Land




Figure 3.14-C-6 Alternative 1 Impacts to Important Farmland and Grazing Land (Sheet 5 of 12)





Figure 3.14-C-6 Alternative 1 Impacts to Important Farmland and Grazing Land




Figure 3.14-C-6 Alternative 1 Impacts to Important Farmland and Grazing Land (Sheet 7 of 12)





Figure 3.14-C-6 Alternative 1 Impacts to Important Farmland and Grazing Land




Figure 3.14-C-6 Alternative 1 Impacts to Important Farmland and Grazing Land (Sheet 9 of 12)




Figure 3.14-C-6 Alternative 1 Impacts to Important Farmland and Grazing Land




Figure 3.14-C-6 Alternative 1 Impacts to Important Farmland and Grazing Land (Sheet 11 of 12)




Figure 3.14-C-7 Alternative 2 Impacts to Important Farmland and Grazing Land





Figure 3.14-C-7 Alternative 2 Impacts to Important Farmland and Grazing Land




Figure 3.14-C-7 Alternative 2 Impacts to Important Farmland and Grazing Land (Sheet 3 of 12)




Figure 3.14-C-7 Alternative 2 Impacts to Important Farmland and Grazing Land







Figure 3.14-C-7 Alternative 2 Impacts to Important Farmland and Grazing Land (Sheet 5 of 12)




Figure 3.14-C-7 Alternative 2 Impacts to Important Farmland and Grazing Land






Figure 3.14-C-7 Alternative 2 Impacts to Important Farmland and Grazing Land (Sheet 7 of 12)




Figure 3.14-C-7 Alternative 2 Impacts to Important Farmland and Grazing Land






Figure 3.14-C-7 Alternative 2 Impacts to Important Farmland and Grazing Land (Sheet 9 of 12)




Figure 3.14-C-7 Alternative 2 Impacts to Important Farmland and Grazing Land




Figure 3.14-C-7 Alternative 2 Impacts to Important Farmland and Grazing Land (Sheet 11 of 12)




Figure 3.14-C-7 Alternative 2 Impacts to Important Farmland and Grazing Land




Figure 3.14-C-8 Alternative 3 Impacts to Important Farmland and Grazing Land




Figure 3.14-C-8 Alternative 3 Impacts to Important Farmland and Grazing Land






Figure 3.14-C-8 Alternative 3 Impacts to Important Farmland and Grazing Land (Sheet 3 of 12)




Figure 3.14-C-8 Alternative 3 Impacts to Important Farmland and Grazing Land






Figure 3.14-C-8 Alternative 3 Impacts to Important Farmland and Grazing Land (Sheet 5 of 12)




Figure 3.14-C-8 Alternative 3 Impacts to Important Farmland and Grazing Land






Figure 3.14-C-8 Alternative 3 Impacts to Important Farmland and Grazing Land (Sheet 7 of 12)





Figure 3.14-C-8 Alternative 3 Impacts to Important Farmland and Grazing Land




Figure 3.14-C-8 Alternative 3 Impacts to Important Farmland and Grazing Land (Sheet 9 of 12)




Figure 3.14-C-8 Alternative 3 Impacts to Important Farmland and Grazing Land




Figure 3.14-C-8 Alternative 3 Impacts to Important Farmland and Grazing Land (Sheet 11 of 12)





Figure 3.14-C-8 Alternative 3 Impacts to Important Farmland and Grazing Land





Figure 3.14-C-9 Alternative 5 Impacts to Important Farmland and Grazing Land




Figure 3.14-C-9 Alternative 5 Impacts to Important Farmland and Grazing Land (Sheet 3 of 12)






Figure 3.14-C-9 Alternative 5 Impacts to Important Farmland and Grazing Land





Figure 3.14-C-9 Alternative 5 Impacts to Important Farmland and Grazing Land




Figure 3.14-C-9 Alternative 5 Impacts to Important Farmland and Grazing Land (Sheet 7 of 12)




Figure 3.14-C-9 Alternative 5 Impacts to Important Farmland and Grazing Land






Figure 3.14-C-9 Alternative 5 Impacts to Important Farmland and Grazing Land (Sheet 9 of 12)




Figure 3.14-C-9 Alternative 5 Impacts to Important Farmland and Grazing Land




Figure 3.14-C-9 Alternative 5 Impacts to Important Farmland and Grazing Land (Sheet 11 of 12)






Figure 3.14-C-9 Alternative 5 Impacts to Important Farmland and Grazing Land






Figure 3.14-C-10 Alternative 1 Impacts to Williamson Act Contract Land





Figure 3.14-C-10 Alternative 1 Impacts to Williamson Act Contract Land (Sheet 3 of 12)


Figure 3.14-C-10 Alternative 1 Impacts to Williamson Act Contract Land





Figure 3.14-C-10 Alternative 1 Impacts to Williamson Act Contract Land (Sheet 5 of 12)









Figure 3.14-C-10 Alternative 1 Impacts to Williamson Act Contract Land




Figure 3.14-C-10 Alternative 1 Impacts to Williamson Act Contract Land (Sheet 7 of 12)







Figure 3.14-C-10 Alternative 1 Impacts to Williamson Act Contract Land





Figure 3.14-C-10 Alternative 1 Impacts to Williamson Act Contract Land (Sheet 9 of 12)








Figure 3.14-C-10 Alternative 1 Impacts to Williamson Act Contract Land




Figure 3.14-C-10 Alternative 1 Impacts to Williamson Act Contract Land (Sheet 11 of 12)






Figure 3.14-C-10 Alternative 1 Impacts to Williamson Act Contract Land




Figure 3.14-C-11 Alternative 2 Impacts to Williamson Act Contract Land




Figure 3.14-C-11 Alternative 2 Impacts to Williamson Act Contract Land (Sheet 3 of 12)









Figure 3.14-C-11 Alternative 2 Impacts to Williamson Act Contract Land





Figure 3.14-C-11 Alternative 2 Impacts to Williamson Act Contract Land (Sheet 5 of 12)






Figure 3.14-C-11 Alternative 2 Impacts to Williamson Act Contract Land (Sheet 7 of 12)








Figure 3.14-C-11 Alternative 2 Impacts to Williamson Act Contract Land






Figure 3.14-C-11 Alternative 2 Impacts to Williamson Act Contract Land




Figure 3.14-C-11 Alternative 2 Impacts to Williamson Act Contract Land (Sheet 11 of 12)





Figure 3.14-C-11 Alternative 2 Impacts to Williamson Act Contract Land






Figure 3.14-C-12 Alternative 3 Impacts to Williamson Act Contract Land




Figure 3.14-C-12 Alternative 3 Impacts to Williamson Act Contract Land (Sheet 3 of 12)







Figure 3.14-C-12 Alternative 3 Impacts to Williamson Act Contract Land





Figure 3.14-C-12 Alternative 3 Impacts to Williamson Act Contract Land (Sheet 5 of 12)








Figure 3.14-C-12 Alternative 3 Impacts to Williamson Act Contract Land (Sheet 7 of 12)







Figure 3.14-C-12 Alternative 3 Impacts to Williamson Act Contract Land






Figure 3.14-C-12 Alternative 3 Impacts to Williamson Act Contract Land




Figure 3.14-C-12 Alternative 3 Impacts to Williamson Act Contract Land (Sheet 11 of 12)








Figure 3.14-C-12 Alternative 3 Impacts to Williamson Act Contract Land






Figure 3.14-C-13 Alternative 5 Impacts to Williamson Act Contract Land




Figure 3.14-C-13 Alternative 5 Impacts to Williamson Act Contract Land (Sheet 3 of 12)









Figure 3.14-C-13 Alternative 5 Impacts to Williamson Act Contract Land





Figure 3.14-C-13 Alternative 5 Impacts to Williamson Act Contract Land (Sheet 5 of 12)









Figure 3.14-C-13 Alternative 5 Impacts to Williamson Act Contract Land




Figure 3.14-C-13 Alternative 5 Impacts to Williamson Act Contract Land (Sheet 7 of 12)




Figure 3.14-C-13 Alternative 5 Impacts to Williamson Act Contract Land







Figure 3.14-C-13 Alternative 5 Impacts to Williamson Act Contract Land (Sheet 9 of 12)








Figure 3.14-C-13 Alternative 5 Impacts to Williamson Act Contract Land




Figure 3.14-C-13 Alternative 5 Impacts to Williamson Act Contract Land (Sheet 11 of 12)





Figure 3.14-C-13 Alternative 5 Impacts to Williamson Act Contract Land





Figure 3.14-C-14 Alternative 1 Impacts to Land Zoned for Agriculture



Figure 3.14-C-15 Alternative 2 Impacts to Land Zoned for Agriculture (Sheet 5 of 12)







Figure 3.14-C-16 Alternative 3 Impacts to Land Zoned for Agriculture







Figure 3.14-C-17 Alternative 5 Impacts to Land Zoned for Agriculture
