


Figure 3.4-A-1 Noise Level Measurement Locations

(Sheet 1 of 13)






Figure 3.4-A-1 Noise Level Measurement Locations

(Sheet 2 of 13)






Figure 3.4-A-1 Noise Level Measurement Locations

(Sheet 3 of 13)






Figure 3.4-A-1 Noise Level Measurement Locations

(Sheet 4 of 13)






Figure 3.4-A-1 Noise Level Measurement Locations

(Sheet 5 of 13)






Figure 3.4-A-1 Noise Level Measurement Locations

(Sheet 6 of 13)






Figure 3.4-A-1 Noise Level Measurement Locations

(Sheet 7 of 13)






Figure 3.4-A-1 Noise Level Measurement Locations

(Sheet 8 of 13)






Figure 3.4-A-1 Noise Level Measurement Locations

(Sheet 9 of 13)






Figure 3.4-A-1 Noise Level Measurement Locations

(Sheet 10 of 13)






Figure 3.4-A-1 Noise Level Measurement Locations

(Sheet 11 of 13)






Figure 3.4-A-1 Noise Level Measurement Locations

(Sheet 12 of 13)






Figure 3.4-A-1 Noise Level Measurement Locations




Figure 3.4-A-2 Land Use Category 2 Noise Impacts—Alternative 1




Figure 3.4-A-2 Land Use Category 2 Noise Impacts—Alternative 1




Figure 3.4-A-2 Land Use Category 2 Noise Impacts—Alternative 1




Figure 3.4-A-2 Land Use Category 2 Noise Impacts—Alternative 1




Figure 3.4-A-2 Land Use Category 2 Noise Impacts—Alternative 1 (Sheet 5 of 13)




Figure 3.4-A-2 Land Use Category 2 Noise Impacts—Alternative 1




Figure 3.4-A-2 Land Use Category 2 Noise Impacts—Alternative 1 (Sheet 7 of 13)




Figure 3.4-A-2 Land Use Category 2 Noise Impacts—Alternative 1




Figure 3.4-A-2 Land Use Category 2 Noise Impacts—Alternative 1 (Sheet 9 of 13)




Figure 3.4-A-2 Land Use Category 2 Noise Impacts—Alternative 1




Figure 3.4-A-2 Land Use Category 2 Noise Impacts—Alternative 1 (Sheet 11 of 13)




Figure 3.4-A-2 Land Use Category 2 Noise Impacts—Alternative 1




Figure 3.4-A-2 Land Use Category 2 Noise Impacts—Alternative 1




Figure 3.4-A-3 Land Use Category 2 Noise Impacts—Alternative 2




Figure 3.4-A-3 Land Use Category 2 Noise Impacts—Alternative 2 (Sheet 2 of 13)




Figure 3.4-A-3 Land Use Category 2 Noise Impacts—Alternative 2




Figure 3.4-A-3 Land Use Category 2 Noise Impacts—Alternative 2 (Sheet 4 of 13)




Figure 3.4-A-3 Land Use Category 2 Noise Impacts—Alternative 2




Figure 3.4-A-3 Land Use Category 2 Noise Impacts—Alternative 2 (Sheet 6 of 13)




Figure 3.4-A-3 Land Use Category 2 Noise Impacts—Alternative 2




Figure 3.4-A-3 Land Use Category 2 Noise Impacts—Alternative 2 (Sheet 8 of 13)






Figure 3.4-A-3 Land Use Category 2 Noise Impacts—Alternative 2




Figure 3.4-A-3 Land Use Category 2 Noise Impacts—Alternative 2 (Sheet 10 of 13)






Figure 3.4-A-3 Land Use Category 2 Noise Impacts—Alternative 2




Figure 3.4-A-3 Land Use Category 2 Noise Impacts—Alternative 2 (Sheet 12 of 13)






Figure 3.4-A-3 Land Use Category 2 Noise Impacts—Alternative 2




Figure 3.4-A-4 Land Use Category 2 Noise Impacts—Alternative 3 (Sheet 1 of 13)






Figure 3.4-A-4 Land Use Category 2 Noise Impacts—Alternative 3




Figure 3.4-A-4 Land Use Category 2 Noise Impacts—Alternative 3




Figure 3.4-A-4 Land Use Category 2 Noise Impacts—Alternative 3 (Sheet 5 of 13)






Figure 3.4-A-4 Land Use Category 2 Noise Impacts—Alternative 3




Figure 3.4-A-4 Land Use Category 2 Noise Impacts—Alternative 3 (Sheet 7 of 13)






Figure 3.4-A-4 Land Use Category 2 Noise Impacts—Alternative 3




Figure 3.4-A-4 Land Use Category 2 Noise Impacts—Alternative 3




Figure 3.4-A-4 Land Use Category 2 Noise Impacts—Alternative 3




Figure 3.4-A-4 Land Use Category 2 Noise Impacts—Alternative 3 (Sheet 11 of 13)






Figure 3.4-A-4 Land Use Category 2 Noise Impacts—Alternative 3




Figure 3.4-A-4 Land Use Category 2 Noise Impacts—Alternative 3 (Sheet 13 of 13)






Figure 3.4-A-5 Land Use Category 2 Noise Impacts—Alternative 5 (Sheet 1 of 13)




Figure 3.4-A-5 Land Use Category 2 Noise Impacts—Alternative 5 (Sheet 2 of 13)






Figure 3.4-A-5 Land Use Category 2 Noise Impacts—Alternative 5




Figure 3.4-A-5 Land Use Category 2 Noise Impacts—Alternative 5 (Sheet 4 of 13)






Figure 3.4-A-5 Land Use Category 2 Noise Impacts—Alternative 5 (Sheet 5 of 13)






Figure 3.4-A-5 Land Use Category 2 Noise Impacts—Alternative 5 (Sheet 6 of 13)






Figure 3.4-A-5 Land Use Category 2 Noise Impacts—Alternative 5 (Sheet 7 of 13)




Figure 3.4-A-5 Land Use Category 2 Noise Impacts—Alternative 5 (Sheet 8 of 13)






Figure 3.4-A-5 Land Use Category 2 Noise Impacts—Alternative 5 (Sheet 9 of 13)




Figure 3.4-A-5 Land Use Category 2 Noise Impacts—Alternative 5 (Sheet 10 of 13)






Figure 3.4-A-5 Land Use Category 2 Noise Impacts—Alternative 5




Figure 3.4-A-5 Land Use Category 2 Noise Impacts—Alternative 5 (Sheet 12 of 13)






Figure 3.4-A-5 Land Use Category 2 Noise Impacts—Alternative 5




Figure 3.4-A-6 Land Use Categories 1 and 3 Noise Impacts—Alternative 1
(Sheet 1 of 7)






Figure 3.4-A-6 Land Use Categories 1 and 3 Noise Impacts—Alternative 1 (Sheet 2 of 7)




Figure 3.4-A-6 Land Use Categories 1 and 3 Noise Impacts—Alternative 1 (Sheet 3 of 7)






Figure 3.4-A-6 Land Use Categories 1 and 3 Noise Impacts—Alternative 1 (Sheet 4 of 7)






Figure 3.4-A-6 Land Use Categories 1 and 3 Noise Impacts—Alternative 1 (Sheet 5 of 7)






Figure 3.4-A-6 Land Use Categories 1 and 3 Noise Impacts—Alternative 1
(Sheet 6 of 7)






Figure 3.4-A-6 Land Use Categories 1 and 3 Noise Impacts—Alternative 1 (Sheet 7 of 7)






Figure 3.4-A-7 Land Use Categories 1 and 3 Noise Impacts—Alternative 2 (Sheet 1 of 7)






Figure 3.4-A-7 Land Use Categories 1 and 3 Noise Impacts—Alternative 2 (Sheet 2 of 7)






Figure 3.4-A-7 Land Use Categories 1 and 3 Noise Impacts—Alternative 2 (Sheet 3 of 7)






Figure 3.4-A-7 Land Use Categories 1 and 3 Noise Impacts—Alternative 2 (Sheet 4 of 7)






Figure 3.4-A-7 Land Use Categories 1 and 3 Noise Impacts—Alternative 2 (Sheet 5 of 7)






Figure 3.4-A-7 Land Use Categories 1 and 3 Noise Impacts—Alternative 2 (Sheet 6 of 7)






Figure 3.4-A-7 Land Use Categories 1 and 3 Noise Impacts—Alternative 2




Figure 3.4-A-8 Land Use Categories 1 and 3 Noise Impacts—Alternative 3 (Sheet 1 of 7)






Figure 3.4-A-8 Land Use Categories 1 and 3 Noise Impacts—Alternative 3 (Sheet 2 of 7)






Figure 3.4-A-8 Land Use Categories 1 and 3 Noise Impacts—Alternative 3 (Sheet 3 of 7)






Figure 3.4-A-8 Land Use Categories 1 and 3 Noise Impacts—Alternative 3 (Sheet 4 of 7)






Figure 3.4-A-8 Land Use Categories 1 and 3 Noise Impacts—Alternative 3 (Sheet 5 of 7)






Figure 3.4-A-8 Land Use Categories 1 and 3 Noise Impacts—Alternative 3 (Sheet 6 of 7)






Figure 3.4-A-8 Land Use Categories 1 and 3 Noise Impacts—Alternative 3 (Sheet 7 of 7)






Figure 3.4-A-9 Land Use Categories 1 and 3 Noise Impacts—Alternative 5
(Sheet 1 of 7)






Figure 3.4-A-9 Land Use Categories 1 and 3 Noise Impacts—Alternative 5 (Sheet 2 of 7)






Figure 3.4-A-9 Land Use Categories 1 and 3 Noise Impacts—Alternative 5 (Sheet 3 of 7)






Figure 3.4-A-9 Land Use Categories 1 and 3 Noise Impacts—Alternative 5 (Sheet 4 of 7)






Figure 3.4-A-9 Land Use Categories 1 and 3 Noise Impacts—Alternative 5




Figure 3.4-A-9 Land Use Categories 1 and 3 Noise Impacts—Alternative 5 (Sheet 6 of 7)






Figure 3.4-A-9 Land Use Categories 1 and 3 Noise Impacts—Alternative 5




Figure 3.4-A-10 Noise Barrier—Alternative 1

(Sheet 1 of 6)






Figure 3.4-A-10 Noise Barrier—Alternative 1

(Sheet 2 of 6)






Figure 3.4-A-10 Noise Barrier—Alternative 1

(Sheet 3 of 6)






Figure 3.4-A-10 Noise Barrier—Alternative 1

(Sheet 4 of 6)






Figure 3.4-A-10 Noise Barrier—Alternative 1

(Sheet 5 of 6)






Figure 3.4-A-10 Noise Barrier—Alternative 1

(Sheet 6 of 6)






Figure 3.4.A-11 Noise Barrier—Alternative 2

(Sheet 1 of 6)






Figure 3.4-A-11 Noise Barrier—Alternative 2

(Sheet 2 of 6)






Figure 3.4-A-11 Noise Barrier—Alternative 2

(Sheet 3 of 6)






Figure 3.4-A-11 Noise Barrier—Alternative 2




Figure 3.4-A-11 Noise Barrier—Alternative 2

(Sheet 6 of 6)






Figure 3.4-A-12 Noise Barrier—Alternative 3

(Sheet 1 of 6)






Figure 3.4-A-12 Noise Barrier—Alternative 3

(Sheet 2 of 6)






Figure 3.4-A-12 Noise Barrier—Alternative 3

(Sheet 3 of 6)






Figure 3.4-A-12 Noise Barrier—Alternative 3

(Sheet 4 of 6)






Figure 3.4-A-12 Noise Barrier—Alternative 3

(Sheet 5 of 6)






Figure 3.4-A-12 Noise Barrier—Alternative 3

(Sheet 6 of 6)






Figure 3.4-A-13 Noise Barrier—Alternative 5

(Sheet 1 of 6)






Figure 3.4-A-13 Noise Barrier—Alternative 5

(Sheet 2 of 6)






Figure 3.4-A-13 Noise Barrier—Alternative 5

(Sheet 3 of 6)






Figure 3.4-A-13 Noise Barrier—Alternative 5

(Sheet 4 of 6)






Figure 3.4-A-13 Noise Barrier—Alternative 5

(Sheet 5 of 6)






Figure 3.4-A-13 Noise Barrier—Alternative 5

(Sheet 6 of 6)






Figure 3.4-A-14: Noise Barrier - CCNM
