- Federal government
- Any other state government
- Federal grants
- The Prison Industry Authority
- Interagency Agreements
- Joint Powers Agreements
- Contracts or agreements with the California State University or the University of California or any of their respective campuses
- Concession contracts
- Revenue/reimbursement contracts
- Contracts or agreements with any county, city, city and county, school or special district (commonly referred to as local agencies)
- Loans
- Local assistance/subvention agreements
- Court-ordered settlements or cost

Other contracts that are excluded from the Authority's Small Business goals per the Authority's Small and Disadvantaged Business Enterprise Policy:

- Expert Witness Contracts
- Third-party Utilities and Municipalities Agreements
- Other Railroads Agreements
- Legal Services Contracts
